**BIRDS HAVE FLOWN.**

**Not Likely that Pater and McKinley Will be Captured.**

Widespread comment has been occasioned by the extraordinary ease with which S. A. D. Pater and Horace G. McKinley, whose Napoleonic operations form the most spectacular chapters in the Oregon land frauds, have made their escape from the jurisdiction of the United States. Few believe that they could have escaped from San Francisco if the federal officials stationed there had been vigilant in the effort to apprehend them.

"The government did not want them" is the common commentary, and it finds very general acceptance. While special agents were busily engaged in Oregon in running down clues and seeking information as to the fugitives, the men supposed to be fleeing from justice were living undisturbed and apparently carefree in San Francisco.

McKinley finally decided to set sail for the orient and he took passage on the steamer Mongolia for Shanghai, November 16. He was accompanied by a wealthy young easterner, who had become interested in a project for building a street railway in one of the large cities of China. At the time McKinley sailed both he and Pater were very much wanted by State Land Agent West, who had brought to light their operations in counterfeit school land certificates and was doing his utmost to run the swindlers to earth. Apparently for the purpose of throwing West off his trail McKinley resorted to a characteristic ruse.

He wrote to a friend in Portland asking him to mail three letters which he enclosed, the object being that they should bear the Portland postmark and thus create the impression that McKinley was in that city. The letter containing these enclosures was dated December 5, the date on the letter. His wife, Marie Ware McKinley, and the postmark corresponded, showing that the letter came through the San Francisco postoffice.

Inasmuch as McKinley sailed to Shanghai November 16, it is probable that he left this letter and the enclosures, with instructions that they be mailed December 5, the date on the letter. If his wife, Marie Ware McKinley, may have been entrusted with the letter. At all events the scheme was well calculated to throw his pursuers off the scent. McKinley well knew the methods of the secret service and knew that if a serious effort should be made to apprehend him one of the first things to be done would be to wait for the mails.

Just about the time that this letter was mailed from San Francisco Inspector Thomas B. Neuhausen received a letter from Seattle, dated December 4, saying that McKinley was endeavoring to escape from the country. The writer was evidently in ignorance of the fact that the bird had flown and expressed the belief that McKinley would sail from Vancouver, B. C. The letter further suggested the arrest of George J. Hibbard and Kay McLay, saying that they had been engaged in some transactions with McKinley and might be forced to disclose his whereabouts.

Neuhausen immediately communicated the information he had received to State Land Agent West, and though both of them regarded the letter with suspicion, thinking it might be a mere decoy. West went to Seattle and made a search for some clue which might lead to McKinley's arrest. He was unsuccessful, and though some information was secured as to McKinley's movements during the previous summer and fall, nothing was learned which was of material importance.

Subsequently reports came from San Francisco to Inspector Neuhausen that the two swindlers were in California. This information was accepted both by Neuhausen and by West as probably correct, and they gave little credence to the rumors that became current several days ago that the two men had fled the country.

Two days ago these rumors were confirmed in a manner that left no doubt as to their accuracy. Evidently Francis J. Henedy is convinced that the fugitives have escaped, although in an interview in San Francisco he stated that he thought they could be located when wanted.

An important question which now arises is whether Pater and McKinley can be extradited, and whether, if this can be done the government will take the necessary steps. It appears to be impossible for the state land agent to institute extradition proceedings without the aid of the federal authorities. If Pater and McKinley were purposely allowed to escape from the government's clutches it is not to be expected that there will be any great effort to bring them back.

The indictments now pending in the federal court against Pater and McKinley charge them with conspiracy to defraud the government. It is said to be doubtful whether such a charge is a sufficient basis for extradition, as the offense charged is not a felony but only a misdemeanor.

**HOWARD FOR LIFE.**

and dead shot who went to Frankfort to kill Goebel in return for a pardon for having killed George Baker in a feud. Personally, Howard does not fill the idea of such a person at all. He would never have been taken for a desperate man from the mountains. He is handsome and of distinguished appearance, of fine physique and unusually graceful with easy manners. He looks like a man of fine intellect and a student. Indeed, he has been a student for five years, as during his imprisonment he has devoted his time to perfecting himself in the law.

Howard was born in Clay county 40 years ago. His father was a school teacher. Howard lived in the mountains all his life and early became an expert shot, like all Kentucky mountaineers. He was first a deputy sheriff of Clay county, then school teacher, lawyer, general storekeeper in the government revenue service and finally assessor of Clay county, which he held when he became involved in the Goebel trouble.

Howard is the victim of a Kentucky feud, whatever were the circumstances of the killing of Goebel. He was in Frankfort the day Goebel was shot, trying to procure a pardon for the killing of George Baker from W. S. Taylor, then governor of Kentucky. The prosecution has maintained that he was to get his pardon for killing Goebel. Howard has maintained that in this seeming connection he was a victim of circumstances.

The Baker—Howard feud broke out in 1897. The Bakers one day ambushed Jim Howard's father and two brothers, killing the brothers and desperately wounding the father. Jim Howard as soon as he heard of it, mounted his horse and rode to the scene. He claims that the Bakers tried to ambush him and that he escaped by using his horse as a shield. In the encounter he shot George Baker to death.

Howard was indicted for the murder of Goebel in April 1900. He was then in Clay county, where he might have remained indefinitely, as the mountaineers are republicans, and would have afforded him protection against an army. But in the month of May Howard went to Frankfort and surrendered. His first trial resulted in a sentence of death, his second of life imprisonment, both being reversed. The third verdict was life imprisonment and was sustained by the supreme court.
