 COLE AND PIERCE.

The people are vitally interested in the election of representatives to the Oregon legislature. While all parties are supposed to and should put up their strongest men for the legislature, in the present campaign there are a few things that the Gazette would like to call attention to. For joint representatives the Republicans of Morrow county have no opposition, but in the race for joint senator appear Dr. Cole and Walter M. Pierce. The campaign in this particular case is active, especially on the part of Mr. Pierce.

Dr. Cole is a quiet, conservative, brainy man. His environments and interests are not associated with any influence that would be likely to turn his efforts in the legislature from the common interest of the people.

Mr. Pierce is a jovial fellow well met, a good talker, with pleasing personality which always means a lot of votes.

Personally the Gazette has no fight with him, in fact we like him, but the jovial Mr. Pierce as the private citizen and the Mr. Pierce as senator might be two different men.

And why. The Gazette will attempt to explain.

In the first place, Mr. Pierce is a very large property holder. Nothing wrong with this, but let us look where his large interests are.

Mr. Pierce is the owner of the Hot Lake Sanitarium. This is well known as a resort for the sick. Hardly a folder is gotten out by the O. R. & N. railroad but what Hot Lake is illustrated and featured. The property is estimated to be worth all the way from \$100,000 to \$250,000. Now suppose that Mr. Pierce goes to the legislature. Here is the railroad company and Mr. Pierce with interests very closely allied. Would a railroad man antagonize Mr. Pierce, would Mr. Pierce antagonize the railroad company? This is only a plain everyday business proposition. What would any man do under the same conditions.

But this is not all. Mr. Pierce is emphatic in his statements that he is opposed to trusts and corporations. Give him credit for all of this. Let us believe that he is, but if elected to the legislature and he should oppose legislation not favorable to railroad interests, how long would it be until the railroad interests would say that a whistling station would be made of Hot Lake. It would only take an order to make all trains run through Hot Lake without stopping. What would Hot Lake be worth without the aid of the railroad? Mr. Pierce's large property would be ruined. No matter what he might think or do about it. He could not help himself.

It is easy to see what we could naturally expect under such conditions with all due respect for Mr. Pierce.

Now to our farmer friends and voters what if a maximum freight rate bill should come up offering some relief to the very unsatisfactory condition now existing. Where would you naturally place Mr. Pierce's vote?

The Gazette believes that these plain facts are worthy of investigation without political prejudice.

Mr. Pierce's record in the legislature helps to bear out the presumption of future action, should he be elected.

Senate bill 38, by Brownwell, making eight hours a day's work in certain occupations. Pierce voted no.

Senate bill 60, to limit hours of service of railway employes.

Pierce voted no. S. B. 54, by Pierce, removing \$5,000 limit for causing death by wrongful act. Mr. Pierce being father of the bill moved for indefinite postponement and is therefore wholly responsible for the defeat of the measure.

Of the above bills much could be said as to their merit, but they were all in direct opposition to railroad interests. What influenced Mr. Pierce's action on the above bills, the Gazette is unable to say, however, the coincidence is at least suggestive.

In these days when the spirit of a greater Oregon is in the air the state can ill afford to assume the handicap of woman suffrage. Most people think that there is no danger of it passing, but when it is considered that six years ago it only failed by a scant 2000 votes in the entire state, and that at that time the woman suffragists had no money, while today they have a campaign fund of more than \$10,000, and have 12 speakers imported from other states campaigning through Oregon, the danger will become apparent. So serious does the danger appear to the business men of Portland that more than 200 of them recently published a protest against woman suffrage over their own signatures. The list as published contained a large part of the commercial manufacturing and industrial interests of the State of Oregon. The men who signed this protest represent all walks of life and all political parties. They are not politicians in any sense of the word. They are certainly typical of the brains of the state, and a protest from them is certainly worth a careful consideration of every citizen. Following is the language of the protest as published: "We, the undersigned, believe that it would be injurious to the general welfare and development of Oregon and therefore unwise to adopt woman suffrage at this time. We believe further that a large majority of the women of the state do not want it. We take this means of recording our opposition to the proposed amendment to be voted upon June 4, 1906."

Judge Bean will get many Democratic votes for the office of circuit judge. This is an office which the people look to the man and the man only. Judge Bean is a man of high standing, integrity and fairness. He is an able lawyer as well as a citizen of high standing in the community. Judge Bean will be our next circuit judge.
