The cattle market this season shows decidedly a better tone than for some time. The demand in general is improving.

For the first time in 13 years the United States government is in the market for silver for subsidiary coinage. Wonder if this is an account of Bryan's London speech.

Wasco county will enforce the law on the sale of infected fruits. This is the only way for Wasco or any other county to keep up a reputation for good fruits. Every other county in the state should follow the example of Wasco. Good fruits can be grown all over Oregon but the orchards must be taken care of.

Oregon has lost as much from forest fires as San Francisco lost in earthquake and fire last April. Oregon's loss is annual, by degrees, and as a rule inflicts nothing upon the individual, hence it creates no sense of state calamity. This year the regular destruction is resumed, despite the majesty of state law and the serene assurance Federal control of forest reserves gave when making the big withdrawals. At the time of estimating the burned area of the state's timber regions in 1903, Federal officials found that a minimum of 5000 square miles of timber land had been devastated. Private estimates place the total much higher.—Telegram.

Heppner and Morrow county people and especially the business community will read with regret the severing of Phil Metschan Jr's business interests in Heppner by the sale of the Palace hotel. Mr. Metschan's success is a good example of what can be accomplished by the proper application of push, energy and brains.
