Mystery Unraveled.

The remains were found scattered over a radius of a mile and a half. So far, all that has been found is the head—discovered several weeks ago—one shoe, containing the bone of the foot and leg—and the coat, vest, collar, and portions of trousers, underclothing and one sock.

In the clothing were drafts amounting to \$1700, two watches and some change, which dispels the thought that the man was murdered for his money.
