The anti-cigarette law passed by the last legislature in the State of Washington, has been declared unconstitutional by Judge Mills of the Superior court. A case was taken from the police court in Tacoma to a higher tribunal for a test.

Speaking of what a newspaper does for its community, the late U. S. Senator Davis, of Illinois, made an address in which he said: "Each year every local paper gives from \$500 to \$1000 in free lines for the benefit of the community in which it is located. No other agency can or will do this. The editor in proportion to his means does more for his town than any other man, and with all his fairness, man with man, he ought to be supported, not because you like him, or admire his writing, but because a local paper is the best advertisement a community can make. Today the local papers are doing work for less pay than any men on earth. Patronize your local paper, not as a charity, but as an investment."

Exceptional prosperity for the Northwest this year is predicted by W. W. Broughton, traffic manager of the Great Northern Railway, as the result of a bumper wheat crop. Mr. Broughton studies wheat carefully each year, and this time he observes that the farmers are going to make a big killing. Speaking of the situation, Mr. Broughton says: "I have come across the country slowly for the express purpose of getting out among the producers and wheat dealers to ascertain crop conditions. Not for many years has the vast stretch of country from Minnesota to the Sound been so prolific with its wheat yield. The crop in Washington state is especially good and heavy. I have crossed the country many times but never did I see a people so happy and contented with their lot as the farmers in the region tapped by the Great Northern and its branches. Railways keep just as good account of the crops as the banks and grain dealers. We also know what is doing in districts other than our own. So it seems reasonable to say that with good crops from Minnesota to salt water, from the Platte to the Saskatchewan in Canada, the entire West will enjoy remarkable prosperity this year. I look for the greatest travel the West has ever seen between the middle of July and the middle of September."

STRONG ARGUMENT FOR CORPORATION TAX.

Sen. or Bourne, of Oregon, who yesterday advocated the corporation tax amendment to the tariff bill, is essentially a man of the people. A progressive type of statesman, he is, at the same time, conservative.

Absolutely independent in thought and action, he has pronounced convictions on the pending legislation, and he presents them in a logical and convincing manner. He does not profess to speak for the President, but there is little doubt that he more accurately outlines the President's view of this excise tax than did the chairman of the Finance Committee, who presented the amendment. It is well within reason to believe also that the heads of many corporations share fully his opinion touching the benefits surely to arise out of the publicity feature of the measure.

As a mere revenue-raising makeshift, as we have said before, the corporation tax would little to commend it, but as a step toward a governmental policy of supervision and control—made necessary by twentieth century conditions—this legislation is of far reaching importance and destined, we believe, to be for the country's general good. It is this aspect of it with which the Oregon senator deals, and his argument is strong and may be read with profit.—Washington Herald.

YOUR BRAIN.

Keep It Plastic by Not Overeating as You Grow Old.

Up to a certain age the brain remains plastic enough so that if an injury occurs to the thought brain the person can begin over again and create new knowledge centers in the other hemisphere.

This has happened in many cases where young people have lost certain powers or faculties by cerebral lesions and have afterward recovered these faculties by developing new centers in the other brain. It rarely happens after the age of forty-five, and the reason is because most persons after passing that age soon clog their brains with calcareous matter by overeating and destroy the plasticity of their brains by filling them with food waste.

If all people past the age of forty-five would live on twelve ounces or less of solid food per day we should soon find that one may receive new ideas as readily at seventy-five as at fifteen. You cannot do it, however, if your brain is a hardened mass of waste matter. If you overeat you will be "rot" in your ways and a has-been at fifty. Keep your phonograph records soft and receptive.—Nautilus.

His Reputation Clung to Him Outside the Theater.


