 National custom sanctions it, and the human heart at its best prompts it.

Let us give thanks for our individual mercies: We have all passed through experiences during the year, some of them too sacred to narrate, in which the goodness of Almighty God has been revealed to us. He has provided not only for our material wants, but has fed us with that bread that has satisfied the hunger of our hearts. He has delivered us from evil. He has given us homes, the sweet companionship of loved ones, and the sacred friendships which have enriched our lives. He has comforted us in our sorrows, strengthened us in our weakness, healed our sickness, given us rest from our weariness, and sent the bright angel of Hope to sing to us his songs of cheer in the time of adversity and troubles.

Let us give thanks for our National blessings; for the bountiful harvests that have been garnered; for freedom from famine, pestilence and war the three great scourges of mankind.

For the awakening conscience of the nation in relation to political corruption, industrial injustice, inequality of rights and privileges, commercial greed, the obligations of the strong to the weak, and national righteousness as the only basis for national prosperity and perpetuity.

For the influence of our national life in fostering the spirit of democracy throughout the world, as witnessed by the uprising in China, and the demand for greater freedom and power on the part of the people throughout the world.

For the growth of the spirit of peace among all nations and for the international arbitration treaties proposed by our own chief executive which have met with such favorable consideration among the leading civilized nations of the world. This would mean national disarmament and the lifting of an oppressive burden from the shoulders of the toiling people of all nations.

That it is our privilege as it is our duty, to share in the labor and inspiration of these mighty movements, which look to the unification of the race in a Kingdom of righteousness and everlasting peace.

There will be a convention of the county courts of the state at Portland from the 12th to the 14th of December. This is to be an important meeting and there will be questions of vast importance to the state at large to be discussed, not the least of which will be road construction and good roads legislation. Morrow county is intensely interested in both of these propositions and our court should be represented by both the judge and the commissioners. Judge Patterson has not yet decided to attend, neither have we heard from our commissioners as to what they will do. They attended the meeting of the convention in Portland last winter and received much valuable information. Our full court should go this year and their expenses should be cleared to the county and paid out of its general funds, for it is to the people's interest to have our officials as well informed on all these questions as they can be. There is no better way to get this information than to meet with the other judges and commissioners of the state who can give out for the benefit of all the experience that they have gathered. We hope that our court may all be able to attend, and that there will be no objection raised to their expenses being met as here suggested. It will be money mightily well spent.

The contract has been let by the Southern Pacific for the first 23 miles of the new railroad projected from Eugene to Coos Bay. Between \$6,000,000 and \$7,000,000 will be spent in the construction of this new line to the Coast.

The poultry department of the Oregon Agricultural College has two hens that have tied for the egg-laying championship of the United States, having laid 259 eggs each during the past 12 months. Until now the record was held by a Main hen, which had 251 eggs to its credit in a year.

Nez Perce, Idaho, lays claim to a model citizen in the person of a Chinaman. Lately that town has raised a publicity fund to exploit its resources and the Chinaman subscribed \$120. His name is Fong Way. Incidentally, Nez Perce, with a population of 1500, is raising a promotion fund of \$10,000, to carry on a two years' work.

The Commercial Club of Standfield, from some reason best known to themselves, have forwarded to Washington D. C., a protest against the west extension of the Umatilla project. Why they should do this we are unable to say at this time not having a copy of the text of the protest. Senator Chamberlain received a copy and has made reply to the same in the following statement: "I think the protest of your club unwise, as I feel any effort unwise having a tendency to delay prosecution of work on the west Umatilla extension. Efforts have been in progress a long time to induce the government to adopt and carry on the work on this extension. Yours is the first organized voice I have heard in opposition. It comes after a strong, persistent, united effort to induce the government to proceed with the work. I regret that I can not indorse your views. I believe it is my duty to do all I can to further the work contemplated."

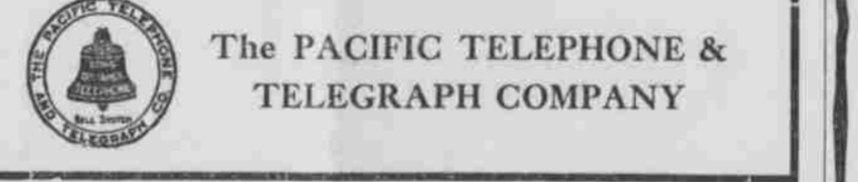
