All that is necessary is to sink an Artesian well. We have in our midst parties who have had experience in the work of sinking such wells. Now would be a good time then to agitate this matter. An Artesian well on one of the hill sides with a good flow of water would be a big bonanza for every man who owns property in and around Weston. The matter therefore merits more than a mere disussion. It is worthy of mature deliberation and decisive and united action. 
