The question as to who shall run the school of Oregon City, the Directors or City Council, was argued last Tuesday before Judge Shattuck at Portland. before Judge Shattuck at Portland.
The decision of the Court will be rendered next Saturday. The Council at its meeting last week dismissed the teachers and closed up the school until the question is determined. Either the Council has but little faith in its close. Conneil has but little faith in its claims or they have acted, in our opinion, hastily in this matter. There would have been no harm done for them to continue the school until the question was settled. If it is the intention, as some appear to talk, to throw obstructions in the way of the school in ease the question is decided against the City Council it will show their determination to either rule or ruin. If the case is de-eided in favor of the Directors, we are e mident that the three men who have been elected Directors will carry on the school as well as the seven Council-men have, provided the people will give them the means to pay for teach-ers, and if they vote down a tax, the fault lies with the citizens who do so, and not with the Directors. There appears to be an impression that nothing but the branches provided in the comcont school law can be taught in case the school has to be conducted in accordance with the general law. This is a mistake. The branches provided by the general act must be taught, but there is nothing to prevent the Directors from carrying on a school of the same grade or higher than the Seminary has been in the past. The only thing is, will the tax-payers vote the necessary tax to pay for it? We shall have more to say on this subject when the decision is rendered.
