City Council met Monday evening, August 7, 1876.

Minutes of meetings of July 3d and 14th read and approved.

Petition of citizens praying that ordi-nance 134, which prohibited the owners of geese or ducks to allow the same to run at large within the city limits, be repealed, was read, and it was moved to lay the petition on the table; carried. following bills were ordered paid : M. MURDERED. - Mike McCormick, a well known character who was sent to the penitentiary from this county a Montgomery, an Indian, and pardoned out by Governor Grover, was murdered in Astoria last Sanday morning. The following are the circumstances as furished by the Oregonian ; McCormick had for some time been employed as a laborer on the streets. He was married, and the couple was living in a small hovel. Both were addicted to the excessive use of strong drink, and were frequently seen intoxicated. Saturday evening the woman was drunk, and remained out all night wandering about the streets. Returning home the next morning or forenoon, she found Methere, who is also supposed to ave been drinking. The supposition which the fatal blow was dealt. About old folks in Ohio. one o'clock the woman came to the door and called to a person who hap pened to be passing, and requested him to come in stating that she thought her husband was dving. Going into their miserable hovel, the person addressed found poor McCormick dying from the effect of a stab made by an ordinary sized butcher-knife, just above the heart. His wife first stated that she had killed him, then afterward that a certain Irishman had done the deed; and still another statement later that some one else had. The general prevailing opinion is that it was her hand alone that guided the fatal knife. She is now in fail awaiting an examination.






