

MEMORIAL DAY.

Its Significance—How it will be Observed Here—Services on Sunday and Monday.

This, like all holidays, came into existence from a simple circumstance. In May, 1866, at a small place in one of the southern states, a new ladies, with a feeling of grief for the loss of those dear to them fresh in their hearts, met together, and, with simple ceremonies, placed upon their graves the "first fresh flowers of spring time." Those who looked on, struck with the beauty and appropriateness of the ceremony, imitated it in their localities, until, in 1868, the soldiers of the north, then rapidly forming the organization of the Grand Army of the Republic, took it up, and spread it, and, by general orders, designated May 30th, in each year, as Memorial Day.

At first, the memorial service of the G. A. R. had in view only those who fell during the period of the actual war; but the fraternity, engendered by years of common suffering and danger, and the growing consciousness of the work done by the humblest soldier, has led them to add to their roll of honor the name of each, as he passes over the line, and answers to the "roll-call" on the other side. Thus taken up by the Grand Army and consecrated to the memory of their comrades, dead, and as a fit occasion for the renewal of their most sacred pledges to their comrades, living, as well as a fitting time to impress upon the young those feelings of patriotism and love of country, that will fit them to perpetuate the priceless boon of universal liberty, which has been secured to them through the death of those whose memories are kept green by the ceremonies of this day, the day has grown in favor, until by legal enactment it has come to be a national holiday; and year by year it is growing to be a custom for all who have lost friends to join with the G. A. R., in their ceremonies, and deck with flowers the graves of their own loved ones.

This is as it should be, and while the Grand Army of the Republic are expected to take the initiative in preparing for the observance of the day, all citizens are invited to participate with them in its solemn ceremonies.

Sedgewick Post No. 10, of this city, is making preparations for the observance of the day, which, as it falls on Sunday, this year, will be observed on Monday, the 31st. On Sunday, May 30th, should the weather be suitable, there will be a union service, at Marion square, at 2:30 o'clock p. m., to which all the churches and the citizens of Salem are invited. The memorial sermon will be preached by Rev. J. A. Hollenbach, pastor of the Evangelical church, and short addresses are expected from pastors of other churches. Music will be furnished by a choir, under the leadership of Prof. Parvin. All old soldiers and sailors are requested to meet at the Post room promptly at 2 o'clock, and join with the members of the G. A. R., in the services.

On Monday the 31st, the procession will form on Commercial street, its right resting on Trade street, at 1:15 p. m., and will march hence to the I. O. O. F. cemetery, where the public services will be performed. The memorial address will be by Dept. Chaplain Rev. T. H. Henderson, of McMinnville.

Persons having flowers to contribute, are requested to send them to the Post room, at 203 Commercial street, over Stager Bros.' store between 10 and 12 o'clock on Monday the 31st inst. All organized societies desiring to participate are requested to notify Comrade Z. M. Parvin, chairman of the committee of arrangements, that they may be assigned places in the procession.

The congratulations that followed gave evidence, in their warmth and cordiality, of the estimation in which the young couple are deservedly held—the bride, by her lifetime residence in this, her native place, and the groom, who, though but for a few years a resident among us, has won for himself an honorable position both in business and social circles.

A SAD ENDING.—Many of our citizens will remember Miss Millicia Pettijohn, a young lady, formerly a resident of this city. She was a grand daughter of Mr. M. C. Pettijohn; and for several years made her home with the family of E. L. Bristow, Esq. She afterwards married Mr. Roberts and returned to Arizona. Her relatives not hearing from her for a long while, Mr. Bristow, at their request, wrote to an I. O. O. F. lodge in Tombstone for information concerning her. On yesterday he received an answer from Cochire Lodge, No. 5, I. O. O. F., of Tombstone, conveying information of the death of Miss Pettijohn nee Roberts, which occurred at Bisbee, Arizona, in 1885. Her death was a tragic one and occurred at the time of the now almost forgotten "Bisbee robbery and murder" which was fully mentioned in the dispatches at the time of its occurrence. When the outlaws were discovered in the act of robbing a store, they commenced firing indiscriminately upon every one in sight. Mrs. Roberts, while standing in a restaurant door, received one of these shots and was instantly killed. The letter mentioned above, further states that the husband, Mr. Roberts, soon after the sad occurrence, closed out his business and left that section and finally drifted into the Comer d'Alene mines, where he has since died. The tragic ending of "Lissie," as she was familiarly known among her intimate acquaintances, will be deeply felt and truly grieved by a large circle of relatives and friends.

VISITING THE SCHOOLS.—County Superintendent Peebles returned yesterday from another round among the county schools. While gone he visited the schools in District No. 78, taught by Miss Waciner, No. 3; Miss Bertie Kaiser, No. 65; Miss Alice Frost, No. 51 under the care of Miss Vanny Patten, in the Parkersville district, under the tutelage of Chas. Howell, the school in Hazel Dell district, presided over by Miss Adella Bowen, the Mt. Angel school, over which E. A. Bennett presides, the one taught by J. S. Graham, in Harmony district, the Grassy Pond school, in charge of Miss Ella Drake, Milster school, taught by Miss Effie Milster, and the Bethany school, in charge of Mrs. Miller. The superintendent brings a very favorable report of the condition of these schools, and reports finding a good attendance, generally. As to things in general about the county he speaks favorably. Says crops look well, and predicts a bountiful hay, grain, fruit, and vegetable yield.

AT THE PENITENTIARY.—Superintendent Collins told a reporter of this paper yesterday that things had begun to "hum" again around the penitentiary. The stove works and foundries are running in full blast, work in the brickyard has been resumed, the workmen are engaged in completing the new brick stable, and are making active preparations to continue the work on the new brick wall. The electric light company is pushing things about its machinery, and will soon have the same in running order. Farming and gardening also give a number of the men confined there much needed employment. When the new wall is completed, and all the improvements now under way are finished, this institution will merit the pride of the people of the state.

FRUIT CROP.—A. F. Miller of the firm of Miller Bros., is a gentleman who is well informed on horticulture. Thursday he told a Portland News reporter that the pear, cherry, and prune crop will be very short this year. Mr. Miller said: "I have just made a short trip into Clackamas county and a portion of Marion, and I find that pears are falling off the trees. Prunes will be very short. In the vicinity of houses the cherries were protected from frosts, and a two-thirds crop is assured. Fifty feet distant the trees bear no cherries. There will be a good crop of apples and peaches. I cannot tell anything about strawberries, further than that they are a month behind. All kinds of vegetables are late, and the ground is too cold to sustain life. Garden seeds are rotting in many places, will have to be replanted."

FLOUR MILL AND WAREHOUSES BURNED.—Wednesday night the large grist mill and three warehouses of Thos. W. Perry at North Yamhill, Yamhill county, were totally destroyed by fire, together with a warehouse belonging to R. R. Laughlin. The total loss is not far from \$20,000. Mr. Perry had \$3000 insurance on the mill and contents in the Liverpool, London and Globe, and \$3370 on the warehouses in the Queen Insurance company. The Liverpool, London and Globe also carried an insurance of \$1320 on wheat in one of the warehouses, belonging to Hugh Gallagher, who died this week. Several farmers had wheat stored in the several warehouses. The origin of the fire could not be learned.

AN ENORMOUS ORDER.—According to a telegram from Port Townsend, says an exchange, the Port Discovery mill has received from Japan an order for ties to the amount of 120,000,000 feet. An adequate conception of the size of this order can be formed when it is known that the mill has never cut more than 20,000,000 feet in one year. It would accordingly take four years of steady work to fill the Japanese order.

EUGENE BRANCH.—A. Klein, of the boot and shoe firm, of Krauss & Klein, will leave this city to open a branch house in Eugene City, on the first of June. Mr. Krauss will remain in charge of the house here. The people of Eugene will find Mr. Klein and family a valuable acquisition to their business and social residents.

DROWNED.—Green Farrens, one of the pioneers of Coos bay, was drowned in Coos river, by his skull capsizing, on Thursday, May 6th. The body was recovered and buried by the A. O. U. W., the following Sunday. Farrens had one of the best farms on Coos bay.

THE ISSANE DANCE.—A reporter of this paper last night witnessed one of the regular dances at the asylum. The dance is for the diversion of the sanest of the insane patients, of which there is quite a number. Some of them dance very well, while others only hop around, sometimes keeping time to the music and sometimes not. In the square dances, the quadrilles, lancers, etc., the figures are performed carefully, yet with a will. Some of the patients wait gracefully, yet with the majority it is but a respite from the confinement of the wards, and a little exercise. A great many of the dancers were quite a study to the writer. One elderly looking man would, after each dance, station himself in front of the music, pull down his vest, put one foot a little in front of the other, drop his arms primly by his side, his chin highly elevated, and await for the musicians to play some "jig," when he would try a double shuffle, to be followed or accompanied by several others. Only males took part in this dance. This same man would then walk primly across the floor and ask one of the female patients, with all the grace and politeness of a "gentleman of the old school" to favor him with a dance, but each time to be met only with a negative nod, or no recognition from the blank staring eyes. He would then walk, with all the staidness possible to imagine, back across the floor, to await the next jig. This is only one of the many curious characters in the dance. Women, who would apparently tip the beam at more than a hundred and seventy-five or two hundred pounds, and whose years were on the shady side of forty, danced as lightly and as joyously, as a girl of seventeen. A good many of them have a power of recognition and several are very sane on some subjects, but the minds of the majority of them are blank. The music is furnished by the attaches of the institution and is very good. The hall in which the dance is held is quite roomy and has a good floor. It is kept scrupulously clean and neat, and the dances, which occur twice a week, are the only oasis in the desert life of the patients.

SOMETHING NEW FOR OREGON.—A thunder storm that has the gall to do any damage is a curiosity in Oregon, and the following is published as a "curiosity." It is from the Oregon City Enterprise: "The thunder storm of last Thursday was very severe in the southern part of the county, and many accidents occurred on account of it. We learn that Arthur Kaylor, who works for Oliver Robbins, on the Molalla, was severely injured. It appears that he attempted to get out of the wagon by driving his team under a large tree. After stopping his team he got out of the wagon and sat at the foot of the tree. He had been there but a few minutes when a stroke of lightning struck the tree, ran down it, hitting Mr. Kaylor up into the air, and landed him some fifteen feet away, where he was found by his friends after the storm was over in an insensible condition. Mr. Kaylor is now improved but is very far from well. The horses were not much injured. John Noblet was hauling a load of wood on Dickey's Prairie, when the storm came, and frightened the horses so that they ran away and spilt out Mr. Noblet and the wood. Chas. Stoker, who lives in the Beaver Creek neighborhood, had his barn badly racked and spilt up by the lightning. It appears that after the bolt struck the center of the barn, on top, that it divided into three bolts, each bolt tearing up the siding and rafters in its way, while one bolt knocked down the doors of the barn that was in its way.

THE "PROHIBITION" RALLY.—The "prohibition" rally was held as announced, at Reed's opera house last evening. The procession, headed by the H. A. C. band, consisting of either five or six "prohibs" who wore badges, and a number of small boys who wanted to hear the music and see the fun. At the opera house a good sized audience of people of both sexes and all political persuasions and ages was present. G. M. Miller, the "prohibition" candidate for congress, spoke at length, in about the same vein as on Wednesday evening, abusing both the old parties, and proclaiming the absolute necessity of a third party, as the only salvation of this land. He made a good many wild statements, that he, or any body else could not prove, but on the whole he was a very fair speaker, much better than Butler, and much poorer than Hermann. He was followed by Mr. Flood, of the "Prohibition Star," whose speech had but one virtue, that of brevity, and the audience was allowed to adjourn at a comparatively early hour. The other speakers advertised failed to show up, for which latter fact the audience seemed to feel thankful.

OREGON PACIFIC NOTES.—Says the Corvallis Gazette: The company will soon begin contracting for piles. Excursions over the Oregon Pacific are being talked of. Contracts for ties are being rapidly let by the company at the rate of 22 cents. The steamship Yaquina on her last trip, brought up a large lot of steel rails for the eastern extension.

Mr. G. W. Hunt, the railroad contractor, is getting every thing in readiness to commence work on the eastern extension of the Oregon Pacific.

TO THE PEN.—Sheriff Martin, of Umatilla county, accompanied by a deputy sheriff, arrived here last evening with two prisoners for the penitentiary. One of them is a man named Scott, who gets two years for stealing 249 head of sheep, and another fellow named Looney, one year for stealing a horse. The man that stole the red hot stove and the brush fence, was not along.

PULLMAN SERVICE RESTORED.—The three Pullman cars, the Albany, Ashland, and Roseburg, have all recently been overhauled, repainted, and refitted, and from this date service will be restored between Albany and Portland. This is a service that is appreciated by the traveling public, and it will now be continued without break in the future.

CELEBRATION AT AURORA.—At a meeting held at Aurora Thursday night it was unanimously decided to celebrate, in a glorious manner, the coming anniversary of American independence, on Monday, July 5th, 1886; and various committees were appointed to attend to the arrangements and details of said celebration.

GRAND RALLY.

A Rousing Reception to the Standard Bearers.

ENTHUSIASTIC REPUBLICANS.

The Candidates Meet a Large Audience at the Opera House—The Speeches.

(From Sunday's Daily)

Last night was one of the republicans' night to yell, and they yelled. The workers of Salem Republican Club No. 1, were busy all day preparing for the reception to that grand, good man, who, by the grace of God, and the strength of the republican party, will be the next governor of Oregon, Hon. Thomas K. Cornelius. Before 7 o'clock, long lines of men, wearing the badge of the club, were seen wending their way towards the court house, soon the band came up, and took its stand on the junction of State and Cottage street. The column was then formed in two long lines on either side of the street facing the road-way, through which the carriages were to pass.

While waiting the coming of the carriages, the band discoursed several lively pieces, and a proposal of three cheers for the Salem Republican Club was responded to with a hearty yell.

At about 7:20 p. m. a line of dust rising in the air, foretold the coming of the guests, and soon the band, preceded by one of that race and color, so much the despised of the democracy, which was freed by the glorious flag he bore after long years of slavery, bearing the stars and stripes, the flag of the United States took up its march playing "Marching Through Georgia," down through the long lines of republicans on the street. Behind followed a carriage drawn by six horses, carrying the present governor, and the next, with the president of the evening, and Hon. H. L. Marston, nominee for treasurer. This was followed by two cabs drawn by four horses each, carrying Hon. Geo. W. McBride, nominee for secretary of state, and the reception committee. A long line of private carriages and buggies came in next, after which the Salem Republican Club No. 1, six hundred strong, began a counter march, falling in on the right, and marching through the center, till the entire procession stretched out a distance of four blocks, with the footmen in double rank. As the carriages passed through the ranks, cheer after cheer rent the air, and made the welkin ring.

The scene was really inspiring as the long line passed along the street, all in excellent spirits, with none of the old determination to succeed nor the strong party affiliations weak in their breasts. As the procession filed past Liberty street on state, three rousing cheers for the grand old republican party filled the ethereal surroundings, and the presence of the people's friend, Judge Waldo, on the corner of State and Commercial, brought forth more cheers. In fact, cheering and a glorious, buoyant spirit, was the order of the evening while the procession was moving.

One noticeable and an always welcome and inspiring feature to the members of the grand party of peace and war, was the long, dense lines of ladies which extended from the starting point, clear around to the opera house. The ladies were and are ever the same staunch friends of the republican party.

The opera house was far from capacious enough to hold all who wanted to hear the speaking and large numbers were turned away. The stage was draped with the national flag, and the stage was beautifully decorated with flowers loaned by Mrs. C. S. Rockenfield from her green house.

THE SPEAKING.

After appropriate music by the band, Gov. Moody introduced Col. T. K. Cornelius, candidate for governor. Mr. Cornelius said he was not a public speaker, but there were a few things which needed explaining. He wanted it understood that while he was a republican, and had always stood faithfully by the principles of that party, still he would not be a political governor in case of an election. He would be a governor for the people of the state. He referred to his record, which Pennoy assailed, and when he said he was proud of it, he was heartily cheered. He did not seek the nomination; it was a free-will offering. He was not a monopolist or a railroad man. He referred kindly to his opponent, Mr. Pennoy, but said he could not approve of his record.

Geo. W. McBride the secretary of state, was introduced, and said he was sorry Rufus Mallory could not be present, as he expected. He referred to Hon. Binger Hermann's record, and hoped his able efforts would be appreciated. He said there are issues in this state, and referred to the eight years of democratic rule before the eight years of republican rule, just now drawing to a close, comparing the one with the other. He said in these last eight years the debt had been reduced over \$600,000, the asylum built and equipped at an expense of over \$180,000, and the credit of the state taken from the verge of bankruptcy and placed on a sound basis; besides the tax has been reduced from 7 mills in 1878, to 3 and seven-tenths mills in 1885. He referred to the prohibition movement, and took the same stand as taken by the STATESMAN, presenting figures to show that the prohibition legislation has been retarded and hindered, rather than assisted by the third party movement.

A. N. Gilbert introduced Henry L. Marston, candidate for state treasurer, and commended him to the support of all the people. Mr. Gilbert said he had been a candidate for the same office before the convention but was not now. Mr. Marston emphatically denied that he was a ring candidate, and the people who heard him don't believe he is. If he was the candidate of a ring, it was the grand republican party of the state.

Frank C. Baker, candidate for state printer, spoke briefly, and thanked the party for recognizing the laboring men by placing him, the representative of a body of organized labor, on the ticket.

that Chas. Johns, the candidate for prosecuting attorney be introduced. Mr. Johns made a short and telling speech.

R. P. Boise, for circuit judge, made a grand and sensible speech, and the audience adjourned with three rousing cheers and a tiger for the whole ticket.

BOARD OF CHARITIES.—It is well known that Dr. R. W. Hill has been engaged for three years in the effort to provide for the supervision of the charities and corrections of the state. His lecture in Portland last February set forth the reasons why this is necessary, and awakened an interest all over the state. This has borne fruit in the organization of a volunteer association of charities and corrections, in connection with, and co-operating with our state board of pardons, of which the governor is ex-officio chairman. This association has members in every county in the state, and will do a good work in preparing the way for a state board, whenever that may be organized by an act of the legislature. A bill has been prepared and will be submitted next winter, which will undoubtedly become a law. The association will be represented at the national convention of charities and corrections which meets at Minneapolis in July, by some member. The secretary is Rev. R. W. Hill, D. D., Salem, Oregon, to whom all communications should be addressed.
