### THE SCHOOL MEETING.

There was a very good attendance at the annual school meeting held Monday. It was a business meeting and every one present seemed to be thoroughly in earnest in desiring to do their duty towards the district.

The matter of electing officers consumed but very little time. John Calvin and Frank Johnson were promptly chosen to succeed themselves as clerk and director.

The committee consisting of F. A. Reavis, J. P. Gardner and Frank Johnson appointed to make a report on the school records and the financial condition of the district made an oral report. Further investigation was deemed necessary and W. R. Holmes, G. W. Hyatt and F. A. Clarke were appointed as a new committee and instructed to report at a meeting to be called by the directors.

J. P. Gardner of the committee appointed to procure plans for a new building, submitted several sketches of buildings as furnished by Portland architects consisting of two three and four room structures all of modern design and ranging in cash from \$2600 to \$3900. Contrary to general expectation, no opposition was manifested towards the districts erecting a new building and issuing bonds for that purpose. The matter was fully discussed and a number of the heaviest taxpayers expressed themselves as being strongly in favor of the move. It is very probable that steps will at once be taken toward submitting the proposition to the voters of the district.

### Need for Packing Houses.

More live hogs are now being shipped east from Oregon and Washington than ever before. It is sincerely to be hoped that some of the numerous projected new packing houses in the northwest may soon materialize. It is hard to explain why the price of live hogs in Oregon should be from one to one and one-half cents less per pound than at Chicago, St Paul and Omaha, while we are importing so largely of hog products from these eastern points—Rural Northwest.

### A BIG SAND STORM.

The Track is Covered to a Depth of About Four Feet.

Railroad men say that the present storm of sand along the Columbia is the worst that has been experienced in many years. In some places the track is covered to a depth of four feet by drifts of sand. It is estimated that it would require eighteen hours to clear the obstruction and allow the trains to come through. This was with the provision that the wind would cease blowing and the sand stop drifting.

Hand power is the only available method of removing the sand, and this requires a great deal of time, as shoveling sand is slow work. There is a fortune awaiting the man who can devise some means of overcoming the sand storms along the Columbia.

The present storm has not been exceeded since the year 1882, so railroad men say. Conductor Gullings, who had charge of the train on the main line at that time, states that trains were blocked for three days.

### Settlers Protected.

House bill No. 5474, introduced February 1 by Mr. Allen of Utah, is of interest to many residents of Eastern Oregon. The bill is to provide for the extension of the time within which suits may be brought to vacate and annul patents upon public lands. The provision of especial interest is found in section one as follows: "But no patent to any lands held by a bona fide purchaser shall be vacated or annulled, but the right and title of each purchaser is hereby confirmed."

### PRECINCT BOUNDARIES.

As there was some errors in the recent published boundaries of voting precincts we have gone over the records and corrected the errors. The principal errors were in the Wallowa and Joseph precincts. Their boundaries are as follows:

### WALLOWA.

Commencing at the corner sec 21 tp 4 n r 43. Thence west on section line to the n w corner sec 19 same tp and range. Thence south on range line between 42 and 43 to the s w corner of sec 19 tp 3 n r 43. Thence west on sec line to Wallowa river, thence up said river to mouth of Minam river, thence up Minam river to tp line between one and two south, thence east on said tp line to the s e corner of sec 31 tp 1 s r 43; thence north to the n e corner of sec 6 tp 1 n r 43, thence east to the n e corner of section 5 same tp and range, thence north on sec line to the n w corner of sec 9 tp 2 n r 43. Thence east to the n e corner of said sec 9, thence due north on sec line to the n e corner of sec 21 tp 4 n r 43 to place of beginning.

### JOSEPH PRECINCT.

Commencing at the corner sec 18 tp 2 s r 45, thence west on said line to the n w corner of sec 18 of said tp and r, thence s on range line between 44 and 45 to the n e corner of sec 25 tp 2 s r 44, thence west on sec line to the n w corner of sec 20 of said tp and range, thence south on range line between r 43 and 44 to the county line, thence east on county line to sec line between 33 and 34 range 45, thence north on sec line to the n e corner of sec 16 tp 2 s r 45 place of beginning.

In description of Lostine predict the number 42 in third line should read 43. In description of Enterprise precinct in third line the no 34 should read 44, and in the 15th line the No. 47 should read 49. In description of Divide precinct in 6th line the word north should read south. In description of Imnaha precinct in 4th line the word east should read south, and in 7th line the No. 48 should read 47.
