Storekeeping in the smaller towns of the country has experienced a radical revolution, consequent upon the advent of the mail order house and the extension of rural free delivery. No longer is the local merchant king in his own territory. He might be if he advertised—Ex.

Bloomington Brothers, New York, recently spent \$15,000 in advertising a special sale of one week's duration. The firm cleared \$25,000 above all expenses. Still, there are merchants who say advertising doesn't pay. We should be generous, however, with the man who knows advertising is a fallacy and a delusion. He's the sort of fellow who lingers on in business for years, and if the sheriff doesn't get him he dies unnoticed; while the bright fellow who advertises judiciously and persistently passes away blest by his friends and envied by the newspapers.

It is evident that Gov. Gear is going to make a vigorous fight for the U. S. Senatorship at the coming session of the legislature. He has two reasons for this, one being a laudable ambition to fill that important position and another that according to the Mays law, for the selection of U. S. senators, he is the choice of his party, as manifested by their ballots at the late state election. That Mr. Gear will meet with decided opposition by members of his own party is a foregone conclusion. There are too many men in his party who are desirous of attaining to that high honor to allow the Governor to walk off with the plum without opposition. However, if the members of the legislature have any respect for the Mays law they cannot fail to support Mr. Gear for the senatorship. The widespread public demand for the election of U. S. senators by the popular vote of the people, was the cause of the Mays law being enacted by the last legislature and, unless the republican members of the coming session are guided by the voice of the electors in this matter, it will be evident that there is no sincerity in the pretense that senators should at least be nominated by the popular vote.—Elgin Recorder.

ROOSEVELT ON TARIFF REVISION.

Extracts of his Speech at Logansport—Opposed to Radical Change.

At Logansport, Ind., President Roosevelt spoke to a large crowd on the revision of the tariff schedule. He regarded the readjustment of the tariff as a serious matter and should be done wisely and without regard to political partisanship. He said in part:

"What we really need in this country is to treat the tariff as a business proposition, and not from the standpoint of the temporary needs of any political party. It surely ought not to be necessary to dwell upon the extreme unwisdom, from a business standpoint, from the standpoint of national prosperity, of violent and radical changes amounting to the direct upsetting of tariff policies at intervals of every few years.

"A nation like ours can adjust itself after a fashion to any kind

of tariff. But neither our nation, nor any other, can stand the ruinous policy of readjusting its business at short intervals. This is more true now than it ever was before, for owing to the immense extent and variety of our products the tariff schedules of today carry rates of duty on more than 4000 articles. Continual sweeping changes in such a tariff, touching so intimately the commercial interests of the nation, which stands as one of the two or three greatest in the industrial world, cannot be but disastrous. Yet on the other hand, where the industrial needs of the nation shift rapidly, as they do with us, it is a matter of prime importance that we should be able to re-adjust our economic policy as rapidly as possible and with as little friction as possible to these needs. We need a scheme which will enable us to provide a reap- plication.

"It is on every account most earnestly to be hoped that the problem can be solved in some manner into which partisanship shall enter as a purely secondary consideration, if at all; that is, in some manner which shall provide for an earnest effort by non-partisan inquiry and action to secure any changes the need of which is indicated by the effect found to proceed from a given rate of duty on a given article; its effect, if any, as regards the creation of a substantial monopoly; its effect upon domestic prices, upon the revenue of the government, upon importations from abroad, upon production and upon consumption. In other words, we need to devise some machinery by which, while persevering in the policy of a protective tariff, in which I think the nation as a whole has now generally acquiesced, we would be able to correct the irregularities and remove the incongruities produced by the changing conditions without destroying the whole structure.

There are two or three different methods by which it would be possible to provide such readjustment without any shock to the business world. My personal preference would be for action which would be taken only after preliminary inquiry by and upon the findings of a body of experts of such high characters and ability that they could be trusted to deal with the subject purely from the standpoint of our business and industrial needs; but, of course, congress would have to decide for the exact method to be followed. Of course, in making the changes, we would have to proceed in accordance with certain fixed and definite principles, and the most important of these is an ayowed determination to protect the interests of the American producer, be he business man, wage-worker or farmer.

PULLMAN ORDINARY SLEEPERS.

Dated August 26, 1902.

The tourist travel between the East and the Pacific Coast has reached enormous proportions in the last few years, and calls for a special class of equipment. To meet this demand the Pullman Company has issued from its shops what it technically calls the "Pullman Ordinary Sleeper." These cars appear similar to the regular sleepers being built on the same plan, but not furnished with the same elegance. They are equipped with mattresses, blankets, sheets, pillows, pillow-cases, towels, combs, brushes, etc., requiring nothing of the kind to be furnished by the passenger. Each car has a stove for making tea and coffee and doing "light housekeeping," and each section can be fitted with an adjustable table. A uniformed porter accompanies each car, his business being to make up berths, keep the car clean, and look after the wants and comforts of the passenger. In each of the trains which are dispatched daily from Portland by the O. R. & N. Co. is to be found one of these "Pullman Ordinary Sleepers." The car attached to the "Chicago-Portland Special" goes through to Chicago without change, and the one in the "Atlantic Express" runs to Kansas City without change. Passengers in this car for Chicago change to a similar car at Granger.

Much of the first class travel is being carried in these cars, the rates being lower, and the service nearly equal to that in the palace sleepers.
