Council (SWC) will host a presentation by Dr. Tim Otten of Oregon State University on source tracking and public health risk assessment for blue-green algae blooms in lakes and downstream water bodies.

This presentation will take place Wednesday, July 29, at 6:30 p.m., in the West Woahink Meeting Hall (Yurt) in Honeyman Park, off Canary Road south of Florence.

New scientific tools and data will be described which have expanded our knowledge on the distribution of toxins
