## ESSENTIAL SERVICES IN LANE COUNTY

Lane County Sheriff's Office correctional services include a jail that houses 256 local offenders, 36-bed Community Corrections Center (work-release), and out-of-custody programs such as Community Service and Sheriff's Work Crew.

The department provides 20-hour patrols per day of urban, suburban and rural areas, including timberlands, waterways and coastal dune areas.

Lane County Justice Court, located in Florence, is responsible for the adjudication of violations and misdemeanors filed as violations of traffic, truck-overload, truancy, civil complaints, Lane County Code violations (such as animal regulation, parks, Lane

ESD and waste management complaints) and related post-adjudicative processes.

Lane County Circuit Court, which is housed in the county's courthouse in Eugene, and operated by the Oregon Judicial Department, hears cases no matter the subject, seriousness or severity of the alleged crime or the amount of money involved in the case.

Lane Transit District operates 24 Park and Ride locations throughout the county along major bus routes, and many locations are served by express or direct bus service to limit travel time.

Rhody Express, a community transit service in Florence, operates Monday through Friday, from 10 a.m. to 6 p.m., and provides transportation around town.

Fares are \$1 for one way or \$2 for all day. The vehicle is wheelchair accessible and includes space for bicycles.
