### Florence Municipal Court Jan. 19

Kourtney Sue Burns pleaded guilty to attempted possession of methamphetamine. She was sentenced to 10 days in Florence City Jail. She must pay \$300 in fines.

Ronald Lee Stacy pleaded guilty to reckless driving. He must pay \$375 in fines and his driver's license is suspended for 90 days.
