and the early literacy grades identified healthy and unhealthy foods using emoticons, and then used them to specifically make healthy food choices. Emolabeling effectively influenced food choices even more than labeling for taste.

For this work, Dr. Privitera won the 2015 Early Career Professional Award from the American Psychological Association.

What To Do Now

While waiting for Dr. Privitera's research to be put into practice, consider these five steps:

1. Keep kids active-at least 60 minutes of moderate physical activity most days.

Serve reasonably sized portions.

3. Provide plenty of fruits and vegetables.

 Drink plenty of water and avoid artificially sweetened drinks.
Limit consumption of sugar and saturated fat.
