Sponsored by the Aerospace Industries Association (AIA) and the National Association of Rocketry (NAR), TARC was created in the fall of 2002 as a one-time celebration of the Centennial of Flight, but by popular demand became an annual program.

Based on local qualification flights, the top 100 teams are invited to Washington, D.C. in May for the National Finals. Top placing teams split more than \$100,000 in cash and scholarships and the overall winning team will travel to the United Kingdom to compete in the International Rocketry Challenge taking place at the Farnborough Airshow
