## Forest Service Road 5500 at Cape Perpetua to be closed

Forest Service Road 5500 at Cape Perpetua will be closed temporarily through Tuesday, Sept. 16, to keep drivers safe while logging operations are in progress.

The road is located two miles south of Yachats off Highway 101, north of Cummins Creek Wilderness.
