NOTICE OF DISTRICT MEASURE ELECTION

Notice is hereby given on September 7, 2016, that a measure election will be held in the Western Lane Ambulance District located in Lane County, Oregon, on November 8, 2016. The following shall be the ballot title of the measure to be submitted to the district's voters:

Caption: **Renew Five-Year Option Levy for Emergency Medical/Ambulance Services.**

Question: Shall the District renew existing 45 cents per \$1,000 assessed value for five years beginning 2017-2018 for emergency medical operations?

This measure renews current local option taxes.

Summary: Western Lane Ambulance District provides emergency medical services to over 20,000 residents across approximately 900 square miles. The District employs 14 highly trained and skilled paramedics who are responsible for delivering critical care (paramedic emergency medical treatment and ambulance transportation) to our communities. The District is staffed to operate three ambulances to ensure residents' needs are met 24 hours a day, 7 days a week.

The current local option levy will expire in 2017 unless renewed. Since the levy was originally passed, service call volume has increased by 24% and operational costs have increased significantly. In addition, property tax limitations in Oregon's Constitution have restricted revenue growth.

Renewing the local option levy allows the District to maintain service levels while keeping pace with growing community demand. Median household cost in Lane County is estimated to be \$6.94/month. The proposed rate will generate approximately \$843,526 in 2017-2018; \$851,962 in 2018-2019; \$860,482 in 2019-2020; \$869,086 in 2020-2021; \$877,776 in 2021-2022 for a total of \$4,312,832. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of estimate and may reflect the impact of early payment discounts, compression and the collection rate.

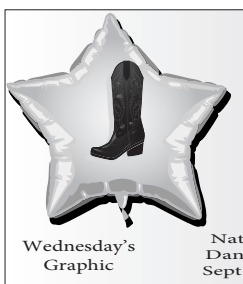
