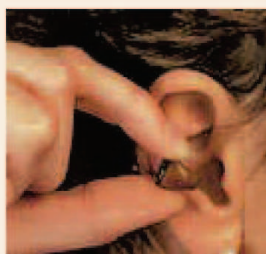

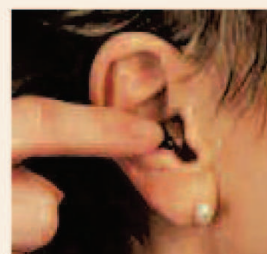
She and her husband, Tony, are avid runners and are active members in the Rockford Road Runners organization, as well as the Runners' Image running group.

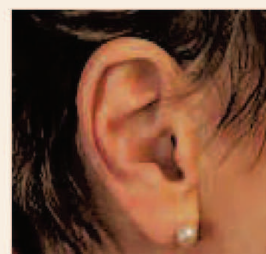
