Sealed bids for the construction of Heceta Water People's Utility District's (Owner) Sutton Lake Road Booster Pump Station Improvements will be received by Carl Neville, General Manager at Heceta Water People's Utility District, 87845 Highway 101, Florence, Oregon 97439 until **2:00 p.m. PDT April 30, 2019** at which time the sealed bids will be opened publicly and read aloud. Bids received after this time will not be accepted. All interested parties are invited to attend.

The project must be substantially complete 120 days after issuance of Notice to Proceed. Estimated construction cost for the Basic Bid is between \$280,000 and \$360,000. The project consists of the following major items of construction:

1. Basic Bid
A. Demolition and removal of existing Sutton Lake Road Pump Station as indicated on the Plans.

B. Installation of new duplex skid mounted pump station consisting of two new booster pumps, meter, pressure relief valve, surge anticipation valve, miscellaneous valves, piping, control system, and fiberglass building at a location near the existing pump station with associated signal and power.

C. Installation of site piping, signal and power conduits, cables, wire and site work.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form. No Bid will be considered unless fully completed in the manner provided in the Instructions to Bidders, and accompanied by a Bid Security executed in favor of the Owner in the amount of not less than 10% of the total amount of the Bid. In addition, all Bidders are required to comply with ORS 656.017 regarding Workers' Compensation. Bidder, Contractor, and subcontractors are required to be registered with Construction Contractors Board.

Pursuant to ORS 279C.505(2), all Bidders must certify with their Bids that they have an employee drug testing program in place. If awarded a Contract, Bidder must provide proof of such drug testing program when executed Agreements are returned to Owner.

Bidders must prequalify with Owner as specified in the Instructions to Bidders, five (5) days prior to Bid opening.

Each Bidder must submit a First-Tier Subcontractor Disclosure Form to the Owner within two working hours of the time for receipt of Bids in accordance with ORS 279C.370.
