Florence Police make arrest in robbery, stabbing on 43rd St.

Police are still seeking information on two suspects involved in Monday night assault.

Monday night at about 10 p.m., Florence Police received a report of a robbery and stabbing at 1750 43rd St. Upon arrival, officers discovered one victim with stab wounds to

his leg and an injury to his mouth, along with another victim who had chased off the suspects.

The investigation revealed that the two victims were sitting in their vehicle when three suspects approached the vehicle and began shouting to give them their money and other items. One suspect, identified as Thomas Lewis Coverdale, opened the passenger door and struck the victim in the mouth with his fist. The victim attempted to kick at the suspect and was stabbed twice

in the leg. The suspects were then chased off by the second victim.

Officers were able to identify the suspect who approached the passenger door as Coverdale, who was located and placed

under arrest. Coverdale, 19, was lodged in the Florence Police Jail on charges of Robbery I, Assault II, Unlawful Use of a Weapon, Unlawful Entry to a Motor Vehicle and on a warrant for Criminal Trespass.

Coverdale will be transported to Lane County Adult Corrections.
