Lane County Sheriffs to participate in national DUII saturation patrols

Lane County Sheriff's Office deputies are participating in a nationwide saturation patrol with a focus on reducing impaired driving and related vehicle crashes. These saturation patrols began Dec. 13 and will continue through Jan. 20. These overtime patrols

are funded by a grant administered by the Oregon Department of Transportation and allow the Sheriff's Office to perform traffic enforcement that deputies would not normally be able to do without the special, allocated funding. This saturation is in con-

junction with a nationwide effort to reduce drunk and impaired driving over the holiday season.

The U.S. Department of Transportation reports that over the past five years, an average of 300 people died in drunk driving crashes the week between Christ-

mas and New Year's nationally. In 2016, 781 people lost their lives in drunk driving related crashes in the month of December nationwide.

The Lane County Sheriff's Office wants to remind motorists to drive safely during the typically haz-

ardous conditions this time of year, drive sober and utilize designated drivers, taxis or other public transportation if they choose to drink. With the passage of Oregon's marijuana laws, this is also a reminder of the impairment marijuana

creates of drivers, impacting their ability to safely operate a motor vehicle.

Driving Under the Influence of Intoxicants (DUII) applies to drivers under the influence of marijuana, as it does with alcohol.
