## SVFR seeks Civil Service Commission member

The Siuslaw Valley Fire & Rescue (SVFR) Board of Directors invite applications from residents interested in serving on the SVFR's Civil Service Commission.

The SVFR district includes a 120 square mile area extending north to milepost 181 on Highway 101, south to milepost 198.5 near the Douglas County line, and east to milepost 9 on Highway 126.

SVFR protects our community with six fire stations, which are staffed with 35 dedicated volunteers who are supported by five full-time employees.

Administrative and management services are provided by Western Lane Fire and EMS Authority.

The Civil Service Commission is a standing committee of three members who oversee and confirm that all district hiring, promotion, and disciplinary processes are being conducted in accordance with the district's civil service rules.

Commission members serve three-year terms which expire Dec. 31. For more information, contact Dina McClure at 541-997-3212.

Interested persons should obtain an application from the SVFR station located at 2625 Highway 101, or from the SVFR web site: [www.svfr.org](http://www.svfr.org). Applications will be accepted until noon on Friday, March 20. After the review of applications, the SVFR board will appoint members at its March 26 board meeting.
