Florence Pregnancy and Parenting Center reopens

With specific coronavirus safety measures in place, the Florence Pregnancy and Parenting Center (PPC) is open again, offering pregnancy and/or parenting support and education. The PPC offers free pregnancy tests and pregnancy options information, prenatal education, parenting education and life skills education. The PPC also has a Stork Boutique with diapers, baby and maternity clothes, and other supplies. All services are free and confidential. The center, located at 1525 12th St., Suite G, is open Tuesdays and Thursdays, 11 a.m. to 4 p.m., or call 541-902-2273 for an appointment. The center's weekly Fun Connections parent/child playgroup will remain closed until the program can safely resume.

Rent, utility assistance available from SOS fund

Siuslaw Outreach Services, through the support of community donations, private foundations, FEMA and Lane County Human Services Commission, has established a fund of \$118,000 to provide rent and utility assistance to households that have been financially impacted by the COVID-19 Pandemic and Governor Brown's executive order. Sheriffs capture suspect in fatal stabbing Friday

The Lane County Sheriff's Office asked for the public's assistance in locating the suspect in a stabbing that occurred south of Florence and reported Friday morning shortly before 1 a.m. The victim was transported to the hospital but did not survive the incident.

Yesterday, deputies were working to identify the victim's next of kin before offering any public identification. The suspect, identified as 32-year-old Gregory Domonic Cross of Florence, fled the area. Deputies searched for Cross for multiple hours with the assistance of the Florence Police Department, Oregon State Police, the Eugene Police Department, Douglas County Sheriff's Office and the Reedsport Police Department, but had been unable to locate him. Cross was described as a white male standing 6'0" tall and weighing approximately 190 pounds with short blond hair and brown eyes. Community members were urged to contact the Lane County Sheriff's Office if they had seen Cross or knew his whereabouts. At approximately 2 p.m. Friday, LCSO reported Cross had been captured. Additional details were unavailable at press time. The public was instructed not to attempt to contact or apprehend Cross as he was considered to be armed and dangerous.

Community members were urged to contact the Lane County Sheriff's Office if they had seen Cross or knew his whereabouts. At approximately 2 p.m. Friday, LCSO reported Cross had been captured. Additional details were unavailable at press time. The public was instructed not to attempt to contact or apprehend Cross as he was considered to be armed and dangerous.
