Oregonians to "keep it legal and keep it safe" when using all fireworks.

The 2020 Oregon fireworks retail sales season opened June 23 and runs through July 6.

The OSFM and its partners want everyone to know what fireworks are legal to use in Oregon without a permit, where they are allowed to be used, and how to use fireworks safely.

"In Oregon, consumer legal fireworks can only be purchased from permitted fireworks retailers and stands," says State Fire Marshal Jim Walker. "State regulations limit where those fire-July, risks for wildfire in many parts of Oregon will be high.

Fireworks can also start structural fires that threaten lives and property, as we have seen in past years."

Residents who plan to visit works: keep children and pets shal, the Oregon Fire Service, public lands and parks for the July Fourth holiday are asked to

leave all fireworks at home.

For residents who purchase leworks may be used. Starting in gal fireworks, the OSFM encourages everyone to practice the four Bs of safe fireworks use: • Be prepared before lighting

fireworks: keep water available by using a garden hose or bucket.

· Be safe when lighting fire-

• Be responsible after lighting fireworks: never relight a dud. Wait 15 to 20 minutes then soak

it in a bucket of water before disposal.

• Be aware: use only legal fireworks and use them only in legal places.

Oregon law prohibits the possession, use, or sale of any firework that flies into the air, explodes, or travels more than 12 feet horizontally on the ground, without a permit issued by the OSFM.

Fireworks commonly called bottle rockets, Roman candles, and firecrackers are illegal in Oregon, without a permit.

For the last reported five years through 2019, there were 1,173 reported fireworks-related fires in Oregon, resulting in more than \$4.9 million in property loss and contents damage. During that same period, fires

County park fees increase begins today

The \$1 parking fee increase will be the first in seven years.

On July 1, 2020, some Lane County Parks fees will increase for the first time since 2013.

The changes include increasing the daily parking fee from \$4.00 to \$5.00 — although the cost of an annual parking pass will remain at \$40.

"We are always very cautious about raising our fees at Lane County parks," said Lane County Parks Manager Brett Henry. "But it is important that we reevaluate our fees from time to time to ensure they are in line with other agencies. The parking and reservation fees that we receive provide the bulk of our budget for park maintenance and improvements."*

The fee increases are the result of a market fee analysis that considered the fees that comparable
