Low-Income Energy Assistance Program receives extra funding

Lane County has received additional LIHEAP-20 funding. This funding is part of the regular Low-Income Energy Assistance Program offered each year through Lane County Human Services.

It is separate from COVID-19 relief programs.

The LIHEAP-20 program helps income-qualified households with their home energy expenses. This is the same program that opened Oct. 1 of last year.

Households that have already received a LIHEAP-20 payment won't qualify for a second LIHEAP payment in the current program year.

LIHEAP-20 provides qualifying households with

a one-time payment toward their energy bill. It may be applied to electricity, natural gas, home heating oil, propane, wood pellets and wood.

To qualify for LIHEAP-20, a household's current gross monthly income must be at or below 60 percent of Oregon's median income.

A household of one person can have a gross monthly income as high as \$2,165. A household of four can have a gross monthly income of up to \$4,163. Households do not need to demonstrate being affected by COVID-19 to qualify.

The amount of assistance a household receives depends on a number of factors.

The program pays the assistance directly into a household's utility account as a one-time payment that ranges from \$250 to \$550.

Interested households may call one of the agencies listed below to be placed on a LIHEAP-20 waiting list starting on Monday, August 24, 2020 at 9 a.m.

Households may also place themselves on a LIHEAP-20 agency's waiting list by visiting www.lanecounty.org/energyassistance.

Households that have already received a regular LIHEAP-20 payment can instead apply for an EAS-CR-20 payment and/or a CARES payment if the household has been affected by COVID-19 financially or due to health.
