In the original application for annexation from Benedick upon annexation, road maintenance does not automatically transfer from Lane County to the City of Florence.

In written testimony, Miller said that the City would need to petition Lane County for transfer of jurisdictional maintenance; this is a public process that can take years.

In January, the language in the application changed to say that the annexation is for the Oceana Drive right-of-way, and that the City of Florence has no plans to ask the county for a transfer of maintenance.

This is what was approved by the City Council on April 5, with no discussion on this point.

The result is that the City and Benedick get to pretend that Oceana Drive is part of the City, providing the contiguity that Benedick needs.
