Lane County Planning Commission now accepting applications for three seats

There are three vacant positions on the Lane County Planning Commission and applications to fill those positions are being accepted now. The open positions include:

- A representative of the Lane County's Coastal area

The Lane County Planning Commission is a nine-member advisory board that makes recommendations to the Board of County Commissioners regarding land use, com-

prehensive plan issues and amendments, as well as other regional planning issues. The group generally meets twice per month in the evenings. "How we implement our comprehensive plan and issues related to land use is how we build our community for ourselves and fu-

ture generations," said Lane County Planning Director Amber Bell. "It's important that the Commission reflect our community both in terms of geography and representation of different voices and experiences." Applicants must be resi-

Possible contaminants found in wastewater stream

Over the past couple of days, Florence Wastewater Treatment Plant Operators have discovered possible contaminants in the wastewater stream. The biological process of wastewater treatment has changed and is not performing as expected. This has caused the possibility of not meeting our DEQ National Pollutant Discharge Elimination System (NPDES) permit and may result in higher levels of enterococcus bacteria being discharged into the Siuslaw River than as stated in our NPDES permit. The wastewater treatment staff is working hard to restore the biological balance in order for the plant can quickly return to normal operations. Staff have

contacted an outside laboratory to process special samples in our investigative process to help determine the chemical contaminate or level of toxicity of an unknown agent that is causing the plant upset. Whatever the chemical or other contaminate is, it is not hampering the facility's ability to deactivate fecal coliforms, but it is creating a situation where it is interfering with the ability to accurately test for enterococcus bacteria. Out of an abundance of caution, City staff have taken water quality samples in the affected area, upstream on the Siuslaw River and downstream on the Siuslaw River. Notices have been posted to advise the public

of the potential hazards and to avoid contact with the water. The public is highly advised to thoroughly cook any shellfish harvested in the immediate vicinity of the Florence Wastewater Treatment Plant and to take universal precautions by washing hands with soap and clean water.
