## Governor announces vaccination measures to address hospital crisis, help keep students safe

Health care workers, K-12 educators, staff and volunteers required to be fully vaccinated

egon Gov. Kate Brown announced two new vaccination measures to address Oregon's hospital crisis, caused by the Delta variant surge, and to help keep Oregon students safe in the upcoming school year and minimize disruptions to in-person instruction:

Oregon's vaccination requirement for health care workers will no longer have a testing alterna-Health care workers will be

required to be fully vaccinated by Oct. 18 or six weeks after full FDA approval, whichever is later. In addition, all teachers, educators, support staff, and volunteers in K-12 schools will be required

or six weeks after full FDA approval, whichever is later.

"The Delta variant has put enormous pressure on our health systems, and health care workers are being stretched to their absolute limits providing life-saving treatment for the patients in their care," said Brown. "I am devoting all available resources to help, and we must proactively implement solutions right now. We need every single frontline health care worker healthy and available to treat patients."

governor outlined the importance of masks and staff vaccinations to protect students: because children under 12 are still not vet eligible for vaccination, masks are a critical mitigation measure to help prevent the spread of COVID-19. Ensuring all the adults around students are fully vaccinated against COVID-19 adds another layer of protection for students as well.

"Our kids need to be in the class-

That's why I've directed the Oregon Health Authority to issue a rule requiring all teachers, educators, support staff, and volunteers in K-12 schools to be fully vaccinated."

> The governor also outlined the steps Oregon is taking to support hospitals during the ongoing surge in cases and hospitalizations, including deploying the National Guard and nurse strike

teams, establishing temporary decompression units to free up bed space, and removing barriers to discharging patients who no longer require hospital-level care. Oregon has also made requests to FEMA and the Biden-Harris administration for additional federal resources and support. The governor announced she has formed a Hospital Crisis Prevention and Response group consisting of health care stakeholders to problem solve in real time and suggest new measures to aid health care workers and hospitals during the ongoing hospital cri-

the vaccine mandates for health care workers. From a few clicks and shares on Facebook, the event reached protesters from throughout Lane County who assembled on the corners of Highways 101 and 126.

People who participated in the event said they disagreed with Brown's ruling and believed their freedom of choice was taken away.

In states like New York and California, similar protests have emerged from groups who have expressed resistance against COVID-19 vaccine mandates for health care workers.

understaffing However, and the health of patients has grown in concern during

the recent resurgence of COVID-19, which has led to a vital moment where medical workers are needed.

"This new safety measure is necessary to stop Delta from causing severe illness among our first line of defense: our doctors, nurses, medical students and frontline health care workers," Brown said.

The local event ran from 10 a.m. through 3 p.m., with approximately 35 people who rallied, including children. Messaging on the signs included "My Body, My Choice," "Medical Freedom," "Freedom to Choose" and "Where There's Risk There Must Be Choice." One sign, carried by a woman in medical scrubs, said, "2020 Hero, 2021 Fired."

The event also featured some chants of "Freedom!" and other phrases.

Earlier this month, Lane County Public Health began offering a \$50 Visa gift card incentive to anyone over

the age of 12 who gets the vaccine from a Lane County Public Health vaccine clinic. As of Sunday, Aug. 22, roughly 233,865 people have been vaccinated out of Lane County's population of 381,365, according to the Oregon Health Authority. At 61.7 percent, this means more than half the population is vaccinated


