### KEEPING TRIM LINES

Dear Central Lincoln PUD,  
We've been living on the North Fork Siuslaw Road for the last six years. We've recognized your significant efforts to provide and maintain our power services.

Recently, my wife noticed and appreciated your extensive efforts to trim back trees that have had the potential to interrupt power, and perhaps, to cause a fire.

I'd been wondering for years if you'd inventoried or surveyed your lines on the road since trees that had fallen had cut power, usually briefly. We've been impressed by your rapid interventions to restore power.

I'm a former Californian and fought forest fires there in the sequoias and coastal redwoods 50 years ago. While it was sometimes harrowing, our crew's efforts can't be compared to the current state of the forest that has been massively affected by climate change.

Back in 1989, a friend in Alaska, the retired state forester, introduced me to the then-nascent problem of spruce bark beetle overwintering enabled by climate change. The explosive damage it was doing to our forests was rapidly causing widespread die offs and presenting the prospects of forest fires beyond one's imagination.

I visited Paradise in early 2019 and observed the devastation resulting from the Camp Fire caused by a PG&E (Pacific Gas & Electric Company) problem.

The current Dixie Fire, which has consumed over a half million acres, and destroyed over 600 homes, also started with a fuse failure after a tree fell.

The local public TV station in San Francisco had this story about the logistical circumstances that combined to result in that fire, which rages on, "Why It Took PG&E 9.5 Hours to Get to the Scene Where Dixie Fire Started."
