Ex-Governor Woods for Vice-President.

Now, while that "slate" is being made, we ask for a recognition. We place before the country and the Republican National Convention, to meet in Cincinnati within four weeks, the name of a gentleman known all over this coast, and as popular as well known. He has been Governor of Oregon by choice of the people, and Governor C Utch by appointment of the President, and in each case filled the office with great ability and satisfaction to the people. He is now a resident of this State and this city, a lawyer eloquent at the bar or on the stand, ever true as steel to the cause of the country; who has gone through such a furnace as that of Governor of Utah, coming out like the Hebrews, without the Brig HAZARD 396 tons. smell or fire upon him. Mounting a wagon which stood in the middle of the street, the personal popularity of the Governor won him a hearing, and in a few appropriate and well-chosen sentences he stilled the passions of his auditors and prevailed on them to disperse and go to their homes. As Governor of Oregon- and Utah, this Pacific coast statesman has won an honorable record, and no better choice for the two highest offices in the Republic could be made, than Blaine of Maine, and Wood of the Golden State.


