Boiled Down for The Astorian.

COLLISION OF FERRY STEAMERS BETWEEN OAKLAND AND SAN FRANCISCO.

THE EL. CAPITAN SUNK TO THE HURRICANE DUCK,

PROBABLY NO LIVES LOST-BUT A GREAT SCARE.

SAN FRANCISCO, Feb. 9. -At about three o'clock this afternoon the ferry steamers El Capitan and Alameda, plying between this city and Oak'and points collided in a dense fog. The port bow of the El Capitan was crushed in, and she filled and sank rapidly. The greatest terror and confusion prevailed. Some of the passengers jumped on board the Alameda, others sprang into the water. The tug Governor Irvin piloted by cries, and whistles, steamed to the rescue and picked up those struggling in the water. Both were ferryboats of the first class. It is not yet definitely ascertained whether any loss of life occurred. The Alameda, which was lower in the water than the El Capitan, ran head on under the guards of the latter. The El Capitan sank to the hurricane deck in twenty minutes.

OTTAWA, Ont., Feb. 19.-In the house of commons yesterday, Mr. Bunster moved for the removal of steel rails from Nanaimo and Esquimalt to Frazer river. The rails were landed at Nanaimo to build the railroad, making Esquimalt the terminus. The motion was agreed to.
