### TELEGRAPHIC NEWS.

#### Eastern States.

Major Haller's store on Whidby island was robbed Saturday night of goods valued at \$400.

The bark Lizzie Marshall, from San Francisco to Port Blakeley, went ashore on the 16th at Dungeness. The captain tried hard to get her off, but failed.

A loan of two millions was secured on the 16th, 6 per cent. bonds of the Northern Pacific railroad, for extending the road 200 miles from Bismark to the Yellowstone.

After something of a lull in the tide, colored emigration from the south has set in again this week, and some three or four hundred people have arrived at St. Louis since Sunday.

Specials from north Texas report a heavy hailstorm, doing great damage to crops on the 15th. At Lisbon, near Dallas, several houses were shattered, live stock killed, and a number of persons severely injured.

The republicans rolled up a round majority in Wisconsin, Judge Cole being re-elected associate justice of the supreme court in the late election by 33,133 majority. The total vote was 168,000 in the state, Cole receiving over 100,000.

#### Foreign News.

A dispatch from Constantinople says England and Russia have approved the appointment of Aleka Pasha as Governor of eastern Roumelia.

Another great storm occurred at Szegeden on Saturday, which destroyed 60 pile-driving stands and carried away and sunk rafts and lighters laden with materials and provisions. The rivers Theiss and Maros are again rising. Ten more corpses have been recovered.

#### Pacific Coast Dispatches.

Lawrence O. Hall was before the police court on the 16th to answer to a charge of grand larceny of funds belonging to the London and San Francisco bank. He waived examination and was held to answer in \$8,000 bail.

Dr. Chalfaut the dentist who shot and killed Josiah Bacon in San Francisco last Sunday at the Baldwin hotel surrendered himself at the central police station on the 16th. He is very haggard and worn, having been roaming about over the hills in the suburbs, and sometimes within the city itself, since Sunday, almost entirely without food or rest. He has made a statement of circumstances connected with the death of Bacon.

A number of English gentlemen have annually been in the habit of presenting to the poorer classes in their neighborhood a variety of flower seeds and a few ornamental shade or fruit trees. The result is that they have encouraged a taste for the cultivation of flowers, and the appearance of many villages has been wonderfully improved.

At the Kerry Assizes, in Ireland, Mr. Justice Fitzgerald summed up directly against a prisoner who was charged with stealing £30. The jury, however, acquitted the accused. The judge said the jury-men were not fit to be jurors, and thought the legislature ought to interfere, and intrust some other tribunal with trials.

A Marseilles newspaper having accused the tax receiver at St. Etienne of zombement, was surprised at having suits brought against it by the tax receivers of 69 different towns and communes bearing the name of St. Etienne, to each of whom is had to pay 100 francs damages, in addition to a fine of 200 francs.

The Russian government discourages the travel of its subjects to foreign countries, for fear of injury to their moral or political views. In order to retain them at home, the price of the pass, without which no Russian is allowed to leave his country, has been lately increased from five roubles to one hundred roubles for each year of life abroad.
