Steamer day. The Columbia left Portland at last night. Spring begins to-day—so says the almanac. Ross Bros. open their new skating rink to-day.

This is the Jewish feast of Rosh Hodesh Nessian. But very few people in town yesterday; too stormy. Slush underfoot, fine overhead.

Rev. J. V. Milligan will be away from town till Saturday. The Valparaiso came down on Sunday, Oeklahama towing.

The Democratic primaries will be held next Saturday throughout the county. The Melancthon and Whistler came in on Sunday, and will load at Knappa.

The California supreme court has decided that the Sunday law in that State is constitutional. The E. T. G. cleared for Queens-town yesterday. She carries 54,196 bushels wheat, worth \$53,664.

Sheridan and company left for Portland on yesterday morning's boat. he goes to Australia in four weeks. Some one, in view of the snow and unseasonably weather, ventures the original remark about Winter lingering on the lap of Spring.

We are under obligations to Capt. Powell for a copy of various reports from him to the Chief of Engineers. We shall quote copiously from the pamphlet. The committee on commerce of the Portland council have furnished Capt. Powell with another thousand dollars to carry on the work of dredging the Willamette.

A herd of sheep has been driven from Eastern Oregon to Nebraska, being two years on the way. By the time they get east of the Mississippi, they will be first-class spring lambs. Walls Walla has passed an ordinance forbidding persons under sixteen to be on the street after seven p. m., from Oct. 1st to April 1st; and during the remainder of the year after eight p. m.

The Oregon inaugurates the system of four-day steamers by arriving this morning. The new departure must prove a great convenience. We shall appreciate it in the matter of mail facilities.

From the Standard we learn that on Friday evening the Ancient Order of Hibernians and a number of their friends held a reunion at the Louisville restaurant. M. J. Gleason was called to the chair and the Astoria delegation occupied seats at the head of the table.

We hear some talk of a stock company being organized to build a theater. It can easily be demonstrated that such an institution would pay, and therefore it ought not be difficult to raise the funds. There are two things in the way of public buildings that Astoria needs—badly. One is a new schoolhouse, the other, a new theater.

As said that the Chinese can tell what time it is by looking into a cat's eyes. Y. M. C. A. Anniversary.

The Anniversary meeting of the friends of the Y. M. C. A. at the M. E. Church, last Sunday evening was an occasion of pleasure to those present. An able address was delivered by Rev. J. V. Milligan; the leading idea of his remarks was, that no one can do anything better in this world than to make himself as humane, intelligent and charitable as his nature will allow, and that charity toward others and a due regard for other's welfare forms an important part of the Christian creed.

He was followed by Rev. John Parsons in a fine discourse, the keynote of which was, that personal effort was needed in Christian work, and that no matter how humble such effort, earnestness and persistence in the right would crown the end with triumph. E. C. Holden, President of the Association, followed in a few well-chosen remarks, relative to the past and probable future of the useful association he has been so long connected with. The gratifying statement was made that the institution was out of debt, was in a live, healthy condition, and looked forward to new endeavors in Christian work that would fittingly illustrate that theirs was not so much an idle precept as an active duty. Rev. Parsons then pronounced a benediction and the large audience dispersed.

Launch of the Barge. At one o'clock yesterday afternoon, "No. One," the first of the Astoria Transportation Company's barges was launched. Quite a crowd had assembled "to see her go off." She presents a very neat appearance in the water, and is a creditable looking craft. She is 42 feet wide, 175 feet long, and will carry one thousand tons of grain. Her cost was a little over ten thousand dollars.

Ordinance No. 449.

REGULATING THE POLICE FORCE OF THE City of Astoria.

The City of Astoria does ordain as follows: Sec. 1. That no regular policeman of this city, while on duty, shall enter or remain in any saloon, house, room or building whatever, excepting on business connected with his duties as such policeman, nor shall he while upon duty, drink or partake of any spirituous, malt, vinous or other intoxicating liquor whatever. Neither shall he be the owner of, or in any manner interested either directly or indirectly in any saloon, bar-room, drinking shop, billiard room or ball alley.

Sec. 2. No police officer shall, while upon duty, be guilty of using any profane or abusive language to, or concerning any person or persons, or of conducting himself in a violent or disorderly manner.

Sec. 3. It shall be the duty of the Chief of Police to report all violations of any of the provisions of this Ordinance by any police officer, to the Common Council forthwith, and to suspend such officer, if it shall appear, on examination, that any such officer shall have been guilty of any such violation, he shall be forthwith discharged from the Police force.
