The little fellow was out in the yard with his sister two years older than he, and in some way got his hand under a hatchet with which she was splitting kindling. The keen edge severed the second, third and fourth fingers of his right hand. Surgical attendance was summoned and the stumps were properly amputated and dressed, the boy bearing the pain like a little hero.

Take it Back!

A Portland steamer, the Gen. Miles, comes into Gray's Harbor and up the river once in two weeks, bringing supplies for the settlers and carrying away lumber and such other produce as may have accumulated in the meantime.—Olympia Transcript. It's been some time now since there has been any attempt to credit Portland with Astoria enterprise; not since the board of trade of that city scooped in their report the whole state from Baker City to Fort Stevens. We ask the Transcript to correct the above. The Miles is the property of the Shoalwater Bay Transportation company, headquarters at Astoria.

Fast Steamers.

The arrival and departure of steamers that go a good deal faster than many railroad trains has got to be a daily occurrence. Yesterday came three in succession; the State of California which arrived down at ten o'clock and after lying at the dock till one started out to sea; then came the Wide West, the prettiest boat on the river, at twenty minutes past eleven, and about half-past one the Fleetwood which puts into every little port on the river, blew her whistle. A boat that will run twenty miles an hour, including all stoppages and landings is now talked of and will soon be in tangible shape.

Salmon Cannery Meeting.

A meeting of cannerymen to discuss matters relative to the present season's work was held at the office of Samuel Elmore last Wednesday evening at eight o'clock. Among those who were present, an ASTORIAN reporter who was on deck, noticed J. W. Cook, Vincent Cook of Clifton; J. G. Megler, of Brookfield; N. W. Tallant and E. A. Tallant of the Cutting Packing company; M. J. Kinney, of the Astoria Packing Co.; Thos. Dealey, of the Columbia Canning Co.; Chas. Thomas, of Thomas & Knowles; Sam'l Elmore, Wm. T. Coleman & Co.'s Astoria agent; F. C. Reed and C. Timmins, of Timmins & Co.; Geo. H. George and Wm. T. Barker, of A. Booth & Co.; S. D. Adair, Wm. B. Adair, J. Adair, Jr., Jay Tuttle, J. Q. A. Bowley, of Ocean Canning Co.; W. J. Barry, E. A. Noyes, F. J. Taylor, of the Seaside Packing Co.; and others connected with the cannery interests of the Columbia.

Upon calling the meeting to order and appointing a chairman and secretary, the purpose for which the meeting was called was stated, viz: to discuss the advisability of reducing the number of boats on the river, and the best means of effecting that result. It was moved and seconded that the fishing boats on the Columbia river be reduced to one half the present number, provided that all interested would so agree. This gave rise to considerable discussion. In response to a question regarding the action of certain cannery companies composed wholly or in part of men who would do their own fishing, Thos. Dealey stated that speaking for those co-operative companies he was of the opinion that they would concede to any agreement to reduce the number of boats so that each cannery would put the same number in the water. A proposition something like the following was then made: Divide the total number of boats on the river by the total number of canneries, and the quotient, whatever it should be, by two, and agree to put just that many boats in the water, thus giving each cannery on the river an equal number of boats in use. Some one made the suggestion that that would give some of the canneries more boats than they had now.

Sam'l Elmore stated that, speaking for Wm. T. Coleman & Co., several of the companies that they represented would be willing to reduce their boats to one-half of the present number. Thos. Dealey said that in his opinion there wasn't a joint stock company on the river that would agree to reduce the number of boats unless each ran just the same number. He also stated that the Columbia Canning company would pay \$1.25 a fish to outside boats and would assess its stockholders for the difference. Mr. Dealey made the further declaration that the idea that he was then and there expressing were not to be taken as his individual sentiments, but that that was the way the joint stock company felt about the matter.

After that there didn't seem to be much room for further discussion and the meeting adjourned.

Astoria Leads.

Our Astoria mechanics are fast acquiring a reputation for good work and skill in mechanism that is a pleasure to record. It seems their fame is going abroad. This season orders come in from California, and on nearly every outgoing steamer machinery for California, Astoria-built. Yesterday, for instance, was shipped on the State of California, soldering machines, retorts, pans, etc., made at the Astoria Iron works for a cannery firm in Sacramento. Arndt & Ferchen are also turning out first-class work, and as for carpenters and other workers they are so busy supplying home orders that they have no time to look at an order from the outside. All of which is as it should be.

Our Coasting Fleet.

There was a rumor afloat yesterday morning that the new Tillamook packer, the A. B. Field, was lost in crossing the bar. Upon inquiring from Chas. Eberman the Tillamook mail carrier, it was learned that the boat was all right; she was in Tillamook bay when he left, awaiting a chance to cross out. She has freight and passengers for Astoria and will be in as soon as the weather clears. The Kate & Anna is down at Nes-tucca; the Ona started for Yaquina and is probably all right, somewhere. The General Miles is in Gray's harbor waiting for an opportunity to tow some schooners to sea and come around herself.
