Special council meeting to-night.

The Emma T. Crowell sailed for Liverpool yesterday.

There will be a special meeting of A. L. of H. to-night.

The State arrived in yesterday morning. The Columbia sails to-day.

O. R. & N. officials are down here on business connected with the rebuilding of the dock.

A bank note was picked up in this office yesterday, which the owner can have upon proper proof of ownership.

Mr. C. E. Paxton, superintendent of schools of Multnomah county, is in the city recuperating from previous indisposition.

On the arrival of the Wide West this evening the Gen. Miles will leave for Tillamook. Fare for the round trip \$7.50.

Frank Fabre will soon begin business again, having secured the fine room in the Odd Fellows' building facing on Cass street.

The Alice goes up stream this morning to bring down the C. South-aid Halbert from Brookfield to Thomas & Knowles' cannery.

Three more of the escaped Salem convicts have been accounted for: one was brought back dead, and two more wounded. Four are still at large.

Astoria cherries are now ripe and in size and flavor are at least equal to any of the imported kind. Indeed the only fault is, there is not enough of them.

Rev. H. K. Hines, editor of the Pacific Christian Advocate, and wife who have been in the city for the past three days return to Portland this morning.

A. J. Cloutrie, whose saddle and harness shop was burned in the late fire has opened again in Page's new building in the rear of the Odd Fellows' temple.

The old pear trees that are now being cut down near Col. Taylor's residence are historic, having borne fruit in 1857; the march of improvement, however, is removing them.

The flags throughout the city were at half-mast yesterday as a token of mourning for the death of Father Powers, in whose demise the entire community feels a sense of personal loss.

In the Justice court yesterday Thos. Wallace charged with larceny from the person of Frank Murphy, was held in the sum of \$500 bail to await the action of the grand jury.

In the police court yesterday afternoon complaints were filed in the case of Robt. Wilgren, Geo. Hill, and Wiseman & Co., charged with a violation of city ordinance number 172. The parties were given till two o'clock this afternoon to plead.

In the state circuit court at Portland last Thursday, the case of the city of Portland against O. Season, being on trial, the jury found a verdict of guilty against Season. This sustains Judge Moroland's decision, and the right of the city to tax all places where liquor is sold.

Courtwright & Hawkins minstrels arrived yesterday and gave our citizens some first class music on their street parade. At eight o'clock Occidental Hall was filled with an appreciative audience; the entertainment was a good one and could have been repeated to an equally large house.

The work of driving piles for the foundation of the pivotal pier of the railroad bridge is progressing favorably. Jos. Smith states that yesterday and day before about twenty-five piles were put in place, being driven to a depth of twenty to twenty-two feet, when it was found that they could be driven no further. There is no trouble about a solid foundation.—Oregonian.

FUNERAL OF FATHER POWERS

The Last Sad Tribute of Respect to One Whom all Hold in Veneration

The funeral cortege accompanying that was mortal of the late T. P. Powers, left his residence in upper Astoria at half-past twelve yesterday, and arrived at the First Presbyterian church at half-past one. The church was filled by a large congregation who testified by their tearful presence the respect they felt for the memory of the good old man who by his long residence here, his earnest action and Christian spirit had won the love and esteem of all. The coffin, a heavy metallic casket, covered with flowers, having been set in front of the pulpit, Rev. J. V. Milligan uttered a short and feeling prayer, after which the choir sang the favorite hymn of the deceased—"Jesus Lover of my Soul." Tears gushed from the eyes of many present as the familiar strains of the tune filled the room. At its close Rev. Dr. A. L. Lindsay, of Portland, offered a fervent prayer followed by Rev. J. T. McCormack, who read the funeral service. Rev. J. V. Milligan, pastor of the church, in fitting words of eulogy paid an eloquent tribute to the memory of the kind friend, the zealous advocate, the wise counsellor, and the steadfast Christian who had gone to his grave, rich in the possession of a well spent life and the sure heritage of glorious immortality, and in the possession of such a plenitude of affectionate remembrance as is rarely vouchsafed to any man in a community. The speaker dwelt at length upon the admirable qualities of Father Powers, his patience, his good intent and beneficial service to the church, and read passages from the diary which he kept during his long sickness. These, more especially, the concluding lines written when the hand was almost stilled in death, were peculiarly affecting. Passing to a sadder theme of thought the speaker dwelt upon the necessity of Christian effort, the lesson that death conveyed, the requirements of the Christian life and the rewards that it assured to those who were faithful to the end.

He was followed by Rev. Dr. A. L. Lindsay, pastor of the First Presbyterian church of Portland, who delivered a short and beautiful address upon the relation of the Christian to the State, his position as a pioneer, and alluding to the thinning ranks of those who are among us with gray heads and bowed forms, the advance guard who came here years ago, said in the name of the pioneers of Oregon he spoke those words of one who was himself a pioneer, and aided in developing the essential elements of civilization in this remote corner of our country. "Safe in the arms of Jesus" was then rendered by the choir, and after a prayer by Wm. Wadhams of Portland, the body borne by Messrs. W. H. Gray, E. C. Holden, H. Powell, Jno. Brice, Wm. Wadhams and Carl Hanson, was carried to the dock, where the steamer conveyed it, together with the friends and relatives of the deceased, to its last resting place by the sea, where thirty-six years ago, Mr. Powers had been ordained as elder in what was then the only Presbyterian church on this coast.

So ends the last act in a life drama of four score years duration, and though the grave cover all that is mortal of the old man whom it was our privilege to call a friend, yet the memory of his kindly presence will not soon leave us, and that the end of life may be as full of hope and as bright with promise as was his, is the most heartfelt wish of all who knew and loved him in life.

Life Saving Service

Major T. J. Blakeney, superintendent of life saving service on this coast arrived on the State yesterday, and starts to Shoalwater bay this morning on an additional tour of observation. It is Major Blakeney's intention to have a complete system of life stations with competent crews attached at every station on this northwestern coast. He is a thorough going official and has personal knowledge of the requirements of the situation. It is his desire to establish a life crew at Shoalwater bay, and have a permanent crew at the cape composed of suitable material, and ready for immediate action when necessary.

A SPECIMEN OF "NEWS"

Did an Astorian Send This?

A DISTURBED CITY. ASTORIA, July 10.—Grave apprehensions are felt among the merchants and business men of this town in regard to the results of the recent action of the vigilance committee. A few days ago two Italians were publicly flogged by the committee and ordered to leave town on short notice. They left, but have returned and are now in the Upper end of town with a large number of Italian fishermen. It is said there are not less than 300 men in camp. They are greatly incensed against the citizens of Astoria for the indignity shown their countrymen and threaten to have revenge. Serious trouble is anticipated and it is feared an attempt will be made to burn the town. A gambler named Jones, who was also flogged and made to leave town, returned and says he will make things warm for the committee. He claims to know the person who lashed him and vows he will kill him. The informant says there is much excitement among the citizens there and it is thought the trouble is not ended.

The above is from the San Francisco Chronicle of the 11th inst. With the exception that no "grave" apprehensions are felt, that no one was "publicly" flogged, that the men that were flogged were not Italians, that they did not come back, that their countrymen do not "threaten" revenge that they are not "in camp" in upper Astoria, that "serious trouble" is not anticipated, that Jones has not come back, and that there is no "excitement" here, the above precious item is correct. But what shall we think of the creature who sent that dispatch. It cannot be that any citizen has done it.

Stabbed in the Breast

At an early hour yesterday morning Leonard Chance, a young man of twenty or twenty-one was stabbed in the breast by a man who is said to be Wm. Barbary, and severely wounded. Chance was standing at the bar in George Hill's saloon, and it is said, was intoxicated, and using abusive language to the bar keeper. His assailant came in and leaning up against the bar draw a knife and stabbed Chance in the breast, severing the cartilage just below the breast bone and inflicting an ugly, but not necessarily fatal wound. Then turning, he made all possible speed out of the place, pursued by a crowd who finally caught him in Astor street, just east of Cass. He was arrested by officer Steabb and Hunter who were with the pursuing party and placed in jail, he was brought before Judge Fox yesterday at half past five. The judge set the preliminary examination for one o'clock this afternoon. Chance was resting easy last evening and seemed in no immediate danger.

No Water This Season

D. P. Thompson had some men at work yesterday fishing out some of the six miles of pipe that fell in the bay after the fire. Sixty-seven pieces were lifted out, and found to be in a very poor condition, not being fit for use; the supposition is that all the pipe is in the same condition. Mr. Thompson will not be able to get any more pipe out here before January 1st, which puts an end to any idea of getting water from Bear creek or any other creek this year. He is now building a reservoir on the hill, 57x125x13 feet, which will hold a million and a half gallons, and will put in place all the city pipe procurable, and do all that he can do with the material at his command.

Jewell Jottings

Timber experts under Mr. Templeman are now camped at Jewell and the surveying party are about two miles above here. The timber experts will probably spend about one week between here and Astoria. Forest fires are raging all around but have not done any damage to the settlers to amount to much, but have burned down and killed considerable valuable forests.
