A Victoria, B. C., dispatch says: Many Chinamen were to-day landed from the Madras in a deplorable condition and were carried ashore. They were in the worse sense of the term "assisted" immigrants, and showed an uncontrollable disposition to settle on the wharf in confused heaps. They were all suffering from an Oriental disease brought on by contamination of the blood, arising mainly from almost exclusive consumption of decomposed vegetable food, consisting of turnips, cabbage, bamboo shoots, etc., furnished by their Chinese purchasers. 
