"A FREE RIVER OR A FREE FIGHT."

The Wasco Sun and other journals east of the Cascades are making a free fight for the completion of the locks at the Cascades and the opening up of the Columbia river to free and unrestricted commerce.

The completion of the locks at the Cascades will be defeated if possible, by corporate capital, as in this free channel of commerce they see a dangerous rival, whose use will restrict oppressive freight charges and dull the edge of profit.

UNEARNED LAND GRANTS.

A WASHINGTON special of the 9th says: Among the roads affected by bills to be introduced by Judge Payson, to forfeit lapse land grants, are the Oregon Central, from Portland to Astoria, 1,120,000 acres; the Oregon and California and the California and Oregon, unpatented lands, 416,837 acres; and certain lands of the Northern Pacific, from Wallula to Portland, 5,504,000 acres.

Among other items of appropriation for the Indian service for next year increases have been asked for and recommended as follows: Arizona, \$18,000; California, \$16,000; Dakota, \$7,000; Idaho, \$4,000; Montana, \$1,000; Nevada, \$6,000; New Mexico, \$10,000; Oregon, \$6,000; Utah, \$14,000; Washington Territory, \$6,000.

A LARGE congressional delegation interviewed President Arthur last Saturday on behalf of O'Donnell, who is sentenced to hang next Monday. What was asked was that the fact of O'Donnell's being an American citizen be taken into consideration, and the belief on the part of many that the trial was not entirely fair.

It is thought that Gen. Hancock's present visit to this coast is in connection with probable presidential nominations. It surely can't be that the general wants to fight 1890 over again!

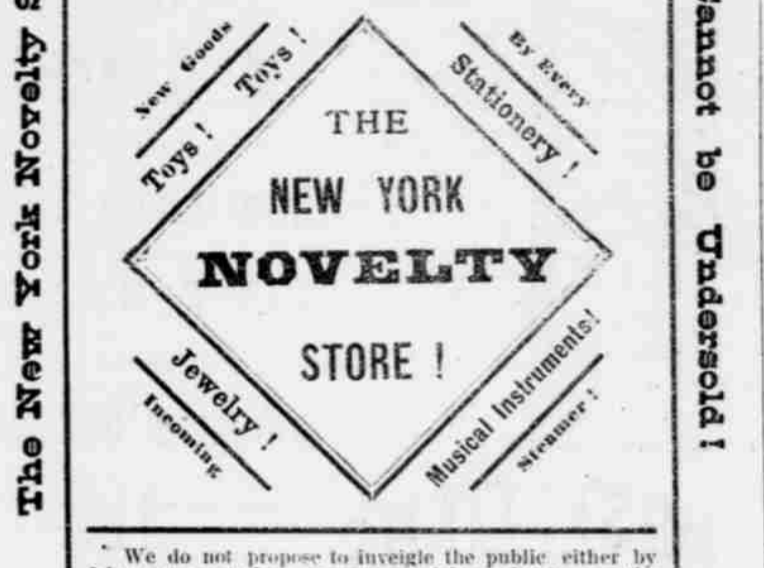
