THE RIEL REBELLION.

WINNIPEG, March 31.—The rebellion started by Riel has gained greater dimensions by the rising of Indians in sympathy. News came from Quappelle to-day that the Indians on the reserves on the File hills had risen in arms and killed the farm instructor there, numbering in all about 500.

The Free Press has received the following from Battleford: We are in imminent dangers from the Indians in the vicinity. Chief Poundmaker has gone into open rebellion, and put the instructor and agent at defiance.

No word has been received at Winnipeg from Riel's vicinity, or from Prince Albert. Operations cannot be undertaken by troops until a force arrives from the east.
