THE OLDEST EX-CONGRESSMAN.
 Recollections of a Man Who Served His State Many Years Ago.

Hon. David Fisher is the oldest ex-congressman in the United States, being in the ninety-first year of his age. Mr. Fisher served in the war of 1812, and soon after married, taking his bride to a small house one mile from the cabin in which General Grant was born. He loves to dwell on the life of General Grant, whose birth he remembers. He tells of dancing with the general's mother when she was Miss Hanna Simpson, and before Jessie R. Grant had courted and wedded her. The old commander was a personal friend of old Tom Corwin, and stumped the state during the hard cider campaign in 1840, at which time he was a Whig. In 1846 he was elected to the thirtieth congress, serving one term and refusing a re-nomination. The lamented Lincoln was a member of the same congress, and the two became fast friends, rooming together for some time in a boarding house where there was perhaps the first step toward the regeneration of our land. Before the war, while traveling in the west, I spent three days at his house in Springfield, and one evening, remarking that I had not received the congressional dictionary, for which I had subscribed and paid, Mr. Lincoln said: "Take one of mine; I have two; and you will see that it speaks better of you than it does of me." In answer to a question made by me to the death of ex-president John Quincy Adams, the old commander replied with evident emotion: "Adams was, next to Mr. Lincoln, the greatest man I ever met. His seat in the house was directly opposite mine, only a narrow aisle separating our desks. The ex-president was very old and for years quite feeble, having a slight touch of paralysis. One day, just before Washington's birthday, in 1848, Mr. Adams laid down from his seat and suddenly put his hand to his head, whereupon I rose up from my desk and caught him in my arms just as he was sinking. The house was in an uproar, but in an instant the word was passed round that Adams was dying and immediately members came to my aid and we carried the fallen statesman into the speaker's room, where three days later he breathed his last. The old man eloquent had gone to his Maker. He never spoke after falling into my arms, save that historical ejaculation uttered just previous to his final dissolution." Mr. Fisher was identified with the Hon. Salmon P. Chase in the organization of the Republican party. He now resides with a married daughter, whose residence is a most beautiful one and five miles from the place where he took his bride so many years ago. In form he is stately and impressive, but has been blind for twenty years. Speaking of social life in Washington, he says the finest entertainment he ever attended was Senator Benton's party to his son-in-law, General Fremont, on his return from the Mexican war. —*Columbian Herald.*

A SWEDISH GODIVA.
 How a Brave Maiden Outwitted a King and Saved Her People.

The 2nd of February in Sweden is considered the midwinter day. In the era of Paganism it was a great festival in honor of the heroine Goa or Goja, defined under the name of Dsa, to whom the whole month was consecrated besides. It is stated that at one time when the country was visited by a frightful famine, the national assembly decided that in order to relieve the general distress it would be necessary to put to death a part of the population, especially the old and infirm. Goa alone dared to protest loudly, and claimed to be able to propose a means of remedying the dearth, which would prove more efficacious as well as more humane. The king ordered the execution of the decree to be postponed; but in the interim, desiring to test the sagacity of the young girl, and to confirm her audacity, he sent her word he would only receive her on condition that she would come to his dwelling neither on foot nor on horseback, nor in a vehicle, neither by day nor by night. Goa solved the enigma. She came to the king's house on a sledge drawn by a goat, holding on to the side of the sledge, with one leg resting on the pole of the sledge, the other on the goat. She wore a fishing net only in lieu of garments, and she came exactly at the epoch of the solstice when the month is still undetermined, at the time of a full moon, but while it was yet twilight. Being permitted to speak, she advised that the old and infirm, in lieu of being exterminated, should be merely sent to the still unpeopled parts of the country, where they would be able to obtain the means of existence without being any burden to the community. The king liked the advice, and as the adviser had charmed him by her beauty and her wit, he took her for his wife.



HENRI ROCHEFORT.

The death of the communist, Chas. Amouraux, gave M. Henri Rochefort an opportunity to address the communists who had assembled to do the last honors to their comrade at the cemetery of Pere la Chaise. The effect of a speech by Rochefort upon such inflammable material, coupled with the death of Hugo can easily be imagined, and ere long a riot occurred which the police were called upon to subdue. Many of the papers demanded the arrest of Rochefort, fearing the result of his ill advised harangues. Rochefort (Comte), Victor Henri de Rochefort Lincy is the son of Marquis Claude Louis Marie de Rochefort Lincy, and was born in Paris, Jan. 30, 1830; he studied at the college of St. Louis, where he evinced a decided taste for poetry. After attempting to study medicine and to gain a livelihood by teaching Latin, he was in 1851 appointed a clerk in the Hotel de Ville. Paying more attention to literature than to this humble employment, he contributed to the second edition of the "Dictionnaire de la Conversation." He was appointed sub-inspector of fine arts at Paris, which post he resigned in 1851. In 1853 he became one of the principal writers of the *Figaro*. His satirical comments on passing events in the columns of the *Figaro* and his caustic criticism of the men and measures of the second empire made the name of Henri Rochefort peculiarly obnoxious to the authorities. In 1856 he was elected a deputy. In the chambers he rendered himself notorious by the course of his personal attacks on the emperor. In December, 1850, he started the *Marseillais*, a newspaper, the character of which is sufficiently indicated by its title; it was seized in 1870 and Mr. Rochefort arrested and confined for six months. On the proclamation of the Republics September 1870 he was placed at the head of a department of state, but soon resigned his appointment. During the brief triumph of the commune he edited an infamous journal, the *Mot d'Ordre*. Various charges were brought against him in connection with this paper, and he was arrested and sentenced to imprisonment for life. He was taken to the penal settlement of New Caledonia. In 1874 he, with several other noted communists succeeded in escaping to Sydney, thence going to Queensland and afterwards to London. Leaving London he proceeded to Geneva where he founded a new *Lanterne*. The general amnesty of July 11th, 1880, permitted him to return to Paris, where he assumed the direction of the new radical paper called *L'Intransigeant*. For articles which appeared in this paper the government began legal proceedings against him, but he was acquitted.
