HOODWINKING A HEN.

Novel Scheme of an Ohioan-Increasing the Yield.

Mr. Workhard was the happy possessor of a good, fat hen, which, like other good, fat hens, laid one egg a day, including Sundays.

A nest with a false bottom was constructed. It worked automatically in such a way that when the good, fat hen laid her accustomed egg it would go beyond the seeming limits of the nest and peacefully repose beneath the false bottom away from gallinaceous sight.

The scheme worked well. Workhard gathered in two eggs a day for some time and then yearned for more. The nest was altered so that two eggs would drop through the false bottom instead of one.
