The total salmon pack of the Skeena river, for the season, is set down at 47,500 cases.

Portland expects the arrival of the *Umatilla* to dredge at St. Helens and elsewhere, before long.

B. Y. Long, next to the Old Corner saloon, keeps fruits in season, and makes a specialty of candies and cigars.

Iwaco is not so lively just now. A good many of the residents are busily employed in the canneries at Shoalwater bay.

In the Cedar street school yesterday 163 pupils were enrolled, a number that will be greatly increased during the week.

Capt. Spencer's steamer *Rosenda* is at Arndt & Ferchen's getting a new condensers. She will tow fish boats on Shoalwater bay.

The county court can't determine the exact amount of the tax levy for the year till the state is heard from, but thinks that county purposes will take about 10 mills. Indebtedness 3 or 4 more and state, etc., 6 or 7 more, making about 20 mills altogether.

The *Alaskan* gives the following as the prices of lumber in Sitka per 1,000 feet: Rough, \$20; scantling, \$25; casing, \$30; single surfaced, \$28; double dressed, \$30; 2-inch planing, \$20. The P. C. S. S. company's charge for conveying lumber from Portland to Alaskan ports is \$12 per 1,000 feet.

The London *Grocer* of August 13th reports as follows: "The situation in salmon has further improved, and in the prevailing scarcity of the spot, prices have run almost wild. Landed parcels of Columbia river fish have been eagerly taken at 27s. to 28s. per case for prime qualities in tall tins, and contracts have been made for arrival on similar terms, say 27s. 6d. Fine salmon in 'flat' tins commands 31s. Owing to the severe falling off in the supply this year, it is now outstripped by the home consumption, and in their anxiety to secure sufficient for their current wants, the trade are giving almost any prices that are asked."

Again the *Portland Journal of Commerce* lies—under a mistake. In its issue of the 3d it says: "The *Nith* paid \$300, for towage inward only at the bar." The *Nith* paid \$300, for towage inward and outward. The regular rate was \$375. She is one of the contract vessels, with 20 per cent. off—leaving \$300 net, for towage in and out. ### Chamber of Commerce.

The Astoria chamber of commerce met in their new and handsomely furnished rooms last evening, president J. Q. A. Bowley in the chair. The principal business transacted was the adoption of the following resolution:

Resolved, That a committee of fifteen citizens be appointed to solicit subscriptions in money to be paid to the first individual or corporation building and equipping a standard gauge railroad from Astoria to connect with any road entering Portland, or to Portland itself; conditioned on the completion of said connecting road within eighteen months from this date.

Said committee also to solicit donations in land and frontage for suitable terminal facilities for said road. J. O. Bozorum.

Mayor Trullinger brought up the matter of extension of docks to the channel, stating that in his individual case the proper facilities pertaining to his business required that he build farther out to the channel, and that he wanted an expression of opinion on the part of the chamber regarding the question. Considerable debate resulted in the adoption of a motion that a committee of three be appointed to confer with a like committee composed of members of the city council to inquire and report thereon. The chairman appointed as such committee J. F. Halloran, S. S. Gordon and Jas. W. Welch. After some minor discussion the meeting adjourned.

### COUNTY COURT PROCEEDINGS.

The county court convened yesterday, present Hon. C. H. Page, judge; E. C. Crow and J. G. Nurnburg, commissioners; C. J. Trenchard, county clerk, and W. G. Ross, sheriff. The application of Daniel Pierson to be admitted as a citizen was allowed.

The petition for a county road, C. B. Watson, attorney, on the Walluski was allowed: O. Sovey, Wm. Joplin and Wm. Beasley appointed viewers.

Petition for a trail in road district No. 5, Geo. Noland, attorney, was allowed.

The application of Fred'k Wickmann to be admitted a citizen was allowed.

The report of viewers of damages in the county road to Kamm's Landing, was allowed.

The petition of allowance to Co. "H," O. N. G., C. W. Fulton, attorney, was allowed, with provision of refunding: that is, whatever the state allowed, if anything, to be given back out of the \$50 a month allowed.

The application of Chas. Ireson to be admitted as a citizen, was allowed.

Consideration of petition for polling place on Bear creek was postponed till January, '88.

In the matter of the estate of Hannah Harrison, F. D. Winton, attorney, order made confirming sale.

Adjudged to 1:30 p. m. Met at 1:30 as board of equalization.

John West, raised \$20,000 on money, notes and accounts. Board adjourned.

The court examined and approved the county assessment roll.

The application of Ole Larson to be admitted as a citizen, was allowed.

The matter of county road on Lewis and Clarke's was set for hearing on the first day next term; clerk to notify Messrs. Ingalls and Tarley.

In matter of petition Charlotte Brailier, guardian H. H. Ingalls, minor, order made allowing petition.

C. L. Hamilton applied for appointment to state university; appointment made.

In matter of estate of E. M. Murphy, Geo. Noland attorney, order made allowing final account.

Requisition of J. F. Bender, for repair of Knappa bridge, allowed.

Matter of petition of B. Gallagher et al., for county road, F. D. Winton, attorney, bond read and approved. R. Carruthers, John Ellis and A. H. Sale appointed viewers, to meet at B. Gallagher's Oct. 3rd.

The assessment on Col. Taylor's land at Smith's point, exclusive of water frontage, placed at \$60 an acre. Adjourned to this morning.

### RECENT DEATHS.

Mrs. Carrie Hammengson, an old resident of Alderbrook, died last Sunday morning, aged 66 years 1 month 6 days. She was a native of Norway, and the mother-in-law of P. H. Johnson. The funeral will take place from his residence at two o'clock to-morrow afternoon; the interment will be in the Hillside cemetery.

Mrs. May Zauner, a native of Germany, wife of Mr. Zauner, died at O'Brien's hotel last Sunday morning of heart disease. Deceased was in the 50th year of her age, and was an old resident of Oregon City and Astoria. She was a sister-in-law of Mrs. O'Brien. The funeral took place at two o'clock yesterday afternoon.

Jasper Empo, son of Martin Empo, of the half-way house, died yesterday morning aged 3 years. The funeral will be from his parents' residence at two o'clock this afternoon. The interment will be at the Hillside cemetery.

### Back Into His Old Position.

New York, Sept. 3.—A positive statement is made here in certain circles that Henry Villard will be elected a director of the Northern Pacific railway September 15, and will probably be made president of the Oregon & Transcontinental company, of which he was the practical founder. It is also said on authority that 130,000 shares of Northern Pacific stock held by the Transcontinental company will be sold to Northern Pacific parties, and scattered, and the company will have three representatives in the Northern Pacific board of directors, Mr. Villard being one. The bonds bought by Villard for the Berlin syndicate were three million 5-per cent. consolidation bonds, issued by the Oregon Railway & Navigation company to retire 7 per cents, which were being carried by the Transcontinental company temporarily.


