## A VERY NEAT LETTER.

From A Very Great Man.  
The letter containing the invitation to Gladstone to attend the centenary celebration of the adoption of the American constitution at Philadelphia was dated June 24. Gladstone was invited as a guest of the committee, and he was informed by the gentleman who conveyed to him the invitation that it was the only one sent to any person not an American citizen or an accredited diplomat, the exception in his case being intended as an expression of recognition of historical ties which bound Great Britain and America before the Declaration of Independence. He was also assured that he would be allowed to make whatever arrangements he pleased and would be entertained in America as no man has been since the visit of Gen. Lafayette.  
Gladstone on July 26 made reply to the letter and assured the committee of the great honor he felt in receiving an invitation to the celebration of the centenary of the American constitution. His letter continued:  
"The attractions of the invitation are enhanced to me by the circumstance that I have always regarded that constitution as the most remarkable work known to modern times to have been produced by human intellect at a single stroke, so to speak, in its application to political affairs. The invitation is accompanied by every accessory that even American hospitality could devise. Had I real option in the case I could not but accept, but the limitation to my strength and time, and the incessant pressure of engagements make me know well that I have none to spare. So far as I can see, the whole small residue of activity at my command will be dedicated to a great work at home. I regard the Irish question as the most urgent and the most full of promise of beneficial results to my country of any that I have ever been engaged in. I ought, perhaps, to add that, viewing jealousies, prevalent in England, it is doubtful whether they might not be stimulated were I to accept the distinction you offer me, which is not less signal than undeserved. The first of these reasons, however, compels me to decline the most flattering proposal I have ever received. I shall watch with profound interest the proceedings of your celebration, when you will look back upon a century of national advancement that is without a parallel in history, and look forward to its probable continuance upon a still larger scale. That you and your children may be enabled by the help of the Almighty worthily to meet the accumulation of high duties and responsibilities, apportioned to ever growing power, will be, I am confident, the prayer of your kinsmen here, who hope, nay, believe, that moral relations between the several portions of our race are widely destined to acquire increasing harmony and closeness. Your obliged and faithful servant."

## THE CHICAGO & NORTHWESTERN STOPS.

NEW YORK, Sept. 8.—The Commercial Bulletin to-day says: "Construction on the Chicago & Northwestern railroad may be said to have come to a decided standstill. President Albert Keep was recently in New York and had a conference with vice-president M. L. Sykes, at which it was decided that the best plan for the Northwestern to adopt is to retard, at least for the present, such active construction work as has been carried on during the past year.

## PACIFIC COUNTY ITEMS.

Several weeks ago Wm. A. Carruthers and L. W. Walker were hunting on the Nema, when they made the discovery of a large tract of open bottom land, extending up stream, calculated to be extensive enough to comfortably hold twenty families. The soil is extremely rich and easily cleared of vine maple and alder. To some small colony of about fifteen or twenty families, this opportunity to settle in a body upon land of such well known value would especially commend itself. As by a united effort much could be accomplished in the way of improvements in a very short space of time.  
Last Friday A. S. Bush, of Bay Center, had Geo. Prescott and J. W. Smith arrested on the charge of breaking into and robbing his store Sunday night, and brought before justice Griswold of this place. The examination took most of Friday and until Saturday noon, and the court concluding that there was not sufficient evidence before it, caused the prisoners to be discharged. Geo. J. Moody prosecuted the case for the territory, and R. Kanaga defended Prescott and Smith. It is now thought that the real culprit belongs to Astoria and that he immediately left the county.  
Capt. Al. Stream, who is at the head of the new steamboat company, is about ready to file articles of incorporation. The object is to raise \$20,000 with stock valued at \$250 a share and a limit of one share to each subscriber. It is calculated that the boat will cost not to exceed \$10,000. Capt. Stream wants to get every person in the county, and especially those at all interested on the bay, to take some stock, and thus make it a common concern with every one to feel that they have an interest in it. A very large proportion of the stock has already been subscribed for.  
Judge Allyn failed to arrive last week within the prescribed six days and Saturday night clerk Wook adjourned the court sine die, and Sunday morning drew the orders for jurors, amounting to some \$500, that they might leave for home. The fees of jurors, witnesses, sheriff and clerk will amount to fully \$700. Much disappointment was felt at the non-arrival of the judge. Since writing the above a letter has been received from judge Allyn, dated at Astoria Sept. 5, announcing that he had been delayed three days by washouts, hence his late appearance.  
W. R. Marion is shipping 200 sacks of oysters every five days to San Francisco. He states that the demand exceeds the supply and that he could ship 30,000 sacks this year if they were to be had. The price paid is 80 cents a basket, sacks furnished. Geo. W. Brown, of Bay Center, is also shipping about 25 sacks every steamer to San Francisco.
