Fishing by Electricity. The idea of utilizing electric lights in fishing has now gone beyond the experimental stage, not only in Europe but in our country, for we read that there are fishermen on the coast of Maine who are now fishing by electric lights. This is not a new departure, said a fisherman recently, but new ways of utilizing the lights have been discovered. The old way was to plunge an incandescent lamp into the water, the connection being made with some source of electricity on board the fishing vessel. When this was used in deep-sea fishing, it was found that the mains to the lamp often got foul of the fishing tackle, or the cable of the vessel, thereby destroying its usefulness. A Frenchman has surmounted the difficulty by adopting a lamp worked by a battery, the whole of which can be thrown overboard and regained when the trip is ended.
