LAND OFFICE DIVISION. Registers and Receivers of the United States District Land Office:

Gentlemen: It has been represented to this office that parties interested in the public lands, and desiring to ascertain what tracts are vacant, find it difficult or impossible to gain the desired information by application to the district land offices.

Section 2335, U. S. R. S., provides that a copy of each township plat shall be kept open at the Surveyor General's office for public information, and other copies should be sent to the places of sale and to the General Land Office.

The public or individuals interested in any tract of land or public record relating to the same are entitled to free access to the information sought, subject to the needs of the public service, which requires that such access shall not interfere unnecessarily with the dispatch of the public business.

You are hereby enjoined to a careful observance of the foregoing, to the end that on persons applying to you for information regarding the public lands in your district, their wants shall be considered as promptly as possible, and every proper facility afforded them for the examination and proper understanding of the plats and records relating to the subject.
