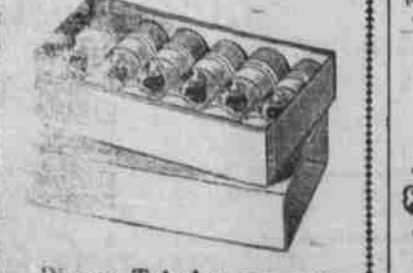
SHERIFF'S SALE.
