

ADMINISTRATOR'S NOTICE OF SALE.

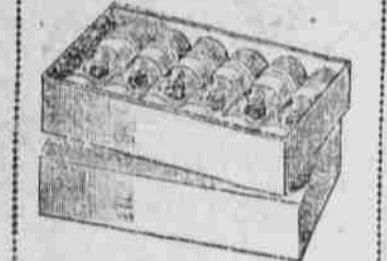
