THE DITTLE MESTUCCA

Albert O. Yates writes to the Oregonian complaining that people wishing to go to the Little Nestucca are frequently inisinformed as to the proper route, This region, he says, is situated in the extreme southern portion of Tillamook county. To reach it, intending settlers must go by train to Sheridan, Yambill county; thence by road direct for about 35 miles, over good country and toll roads, passable in the worst of winters. There is a daily mail route to Tillamook. "We have," says he, "one of the finest dairy and fruit regions on the Pacific Slope. The railroad survey from Albany to Astoria runs directly through the settlement, which is only 10 miles from the steamer landing at the 'Little Nestucca bay.' About 90 or 100-ton steamers can come in over the bar at all times except the worst stormy seasons of winter (but they do not carry passengers), there being about 12 feet of water on the bar at high tide. We need a good, live merchant in the Little Nestucca settlement, who will command a large cash trade, and will find a market for such productions as the country can supply. We have three good school districts and two postoffices, with a tri-weekly mall from Dolph, on the Tillamook route. The town of Woods is four miles up the bay, where we now chiefly trade."
