ADJOURNED SINE DIE

A Good Platform Adopted With Enthusiasm.

FULL COUNTY TICKET NAMED

The Work Well and Harmoniously Done-The Ticket a Strong One.

The Clatsop county Republican convention met, pursuant to previous adjournment from the 24 inst., at the McKinley club room, and after being called to order by Chairman W. F. McGregor, immediately adjourned to Fisher's hall.

The committee on order of business reported the following order of nominations, which was agreed to, viz.:

State senator, representative, clerk, sheriff, treasurer, recorder, county judge, county commissioner, assessor, superintendent of schools, surveyor.

The committee on platform then submitted the following declaration of principles, which was unanimously adopted, amid much enthusiasm:

First—That while we deplore the industrial and business stagnation that now exists and since the placing of the reins of government in the hands of the Democratic party, has prevailed throughout the land, bringing distress and suffering upon our working people, prostrating our industries, and causing commercial and business failures and bankruptcies, to an extent never before experienced or even approached in the history of the nation, we feel that we do but voice the sentiment of the nation in charging the Democratic party with the sole responsibility for this unfortunate condition, produced by its avowed hostility to and untiring assaults upon that policy of protection to American labor and American products for which the Republican party has ever contended, and the adoption of which, during over thirty years of Republican rule, developed the resources and stimulated the industries of the nation and blessed its laboring, producing and commercial classes with a prosperity unapproached in all the history of the world.

While a justifiable pride in the history and achievements of our party will ever abide with us, we are actuated by but one purpose, and that is to secure a return of that prosperity we have ever enjoyed in the past under Republican rule.

We have no unkind words for those who have opposed us in the past, but earnestly believing in the principles and policies of our party, and that the adoption thereof by the government is the only means of giving renewed life to our expiring industries and starting again in motion the wheels of trade and commerce, giving employment to our laborers, a market to our producers and prosperity to all.

We call upon every citizen, irrespective of former political associations, to unite with us for protection, reciprocity and prosperity.

Second—We indorse the platform adopted by the Republican state convention of this state at Portland, April 11, 1894.

Third—We favor the construction of good roads and highways throughout the county, and that they be kept in such condition that our farmers may have secure and easy access to our local markets, to the end that they may supply our people with the products of the farm that we are now so largely importing.

After which the convention adjourned until 12:30, when a caucus was held, lasting until 4 p. m. Thereupon the convention re-assembled, and the following full county ticket was nominated:

County Assessor—Alfred Gibbons. Superintendent of Schools—C. C. Brower.

County Surveyor—Richard Harry. Coroner—Adolph Johnson.

After the nominations were finished, C. J. Curtis, candidate for representative, was called for and made a few brief remarks. He was followed by C. F. Lester, candidate for representative, after which the convention adjourned.

The ticket is considered to be one of the strongest ever nominated by the Republicans in the county, and its election is generally conceded.
